This provision meets requirements

The premises are safe and secure, to enable children to play in safety. There is a range of age-appropriate resources and planned activities to keep children occupied.
- The provider and her staff work in partnerships with parents and schools. For example, the organisation provides a parents' page on their website to provide information about the provision.
- The provider ensures that children in the early years age range have a key person to support them at the club. They understand how to provide age-appropriate activities that complement children's time in school.
- The provider monitors staff practice regularly. She uses the information she gathers, along with feedback from parents and children, to make ongoing improvements to the provision.
- Staff follow the provision's behaviour management policy to manage children's behaviour in a positive way.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector met with the provider to discuss how the provision operates, staff recruitment and vetting, safeguarding and behaviour management.
- The inspector spoke to the provider about how she monitors staff practice and makes ongoing improvements.
- The inspector viewed the company's website to look at policies and the parents' information page.
- The inspector visited the premises where the holiday club takes place and looked at the areas used, indoors and outside.

YPM After-School Club at St John's Angell Town registered in October 2016. It operates from several rooms in St John's Angell Town Church of England Primary School, in the Borough of Lambeth. The club operates during school holidays throughout the year, from 8am to 6pm from Monday to Friday. Staffing is dependent on the numbers of children attending, but includes a manager with a level 3 qualification.
