Part 1. Quality of education provided

- The school's curriculum policy and related long-term programmes of study have been suitably extended to account for pupils in Years 5 and 6. Planning covers all the required areas of learning, and takes account of pupils' different abilities and interests.
- The planned curriculum includes detailed coverage of English language, mathematics, biology, chemistry, physics, arts, crafts and design, geography, history, physical education, technology (encompassing computing and electronics) and advanced life skills (which include, for example, cookery, woodwork, horticulture, sewing and vehicle maintenance).
- The curriculum includes a comprehensive 'cosmic education' (personal, social, health and economic education) programme, which is likely to provide pupils in upper key stage 2 with ample opportunities to learn about fundamental British values, equality and to develop spiritually, morally, socially and culturally.
- The independent school standards in this part are likely to continue to be met if the material change is implemented.

- The school is an independent, co-educational Montessori day school with an Islamic ethos. It opened in September 2017, following the closure of Alamiyah Pre-school, to cater for pupils from three to nine years of age.
- The school's most recent inspection was its first full standard inspection in May 2018.
