Summary of key findings for parents

The provision is good

- The manager and staff are a very committed team. They successfully create a safe, welcoming and inclusive environment. Children, including those who have special educational needs and/or disabilities, thrive at the nursery and make exceptional progress from their individual starting points.
- Staff are excellent role models who value each child as the unique individuals that they are. Children are extremely sociable and highly motivated to learn. They develop exceedingly secure attachments to their key persons, which significantly helps to build on their self-esteem.
- The manager and staff monitor the progress made by individual and groups of children extremely well. This enables them to identify any gaps rapidly and provide effective support for children to catch up quickly and make good progress in their learning.
- Partnerships with parents are very good. Staff provide an extensive array of information for parents. Detailed information on their individual child's learning is shared continuously with parents to complement learning between home and the nursery.
- The manager demonstrates a strong drive to continually improve practice. She strives for excellence and fully involves staff, parents and children in reviewing and refining the nursery provision.

It is not yet outstanding because:

Occasionally, staff do not make the most of opportunities to challenge older and the most-able children's understanding of wider mathematical concepts, including estimation and prediction.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

■ enhance opportunities for the older and most-able children to develop a greater understanding of wider mathematical concepts, including estimation and prediction.

Inspection activities

- The inspector viewed all areas of the premises used by children. She observed the quality of teaching during activities and assessed the impact this has on children's learning.
- The inspector engaged in discussions with staff and children throughout the inspection at appropriate times. She held a meeting with the nursery manager.
- The inspector viewed documentation, including public liability insurance, policies and procedures, and the suitability checks of staff.
- The inspector carried out a joint observation with the manager. She discussed the self-evaluation and the impact this has on the nursery.
- The inspector spoke to a number of parents and other professionals during the inspection and took account of their views.

Inspection findings

Effectiveness of leadership and management is good

The arrangements for safeguarding are effective. The provider who is also the manager, fully understands her role and responsibilities. Staff have a very good understanding of how to keep children safe. They have a very secure knowledge of the signs and symptoms that may indicate possible abuse and know to act swiftly should they have any concerns regarding a child's welfare. Staff regularly meet with other professionals. For example, they attend multi-agency meetings with parents and other professionals to ensure children's individual needs are met. Staff receive regular observations of their practice, supervisory meetings and ongoing training opportunities. This helps to improve staff practice. Parents comment that they are very happy with the service provided and their children really enjoy attending the nursery.

Quality of teaching, learning and assessment is good

The well-qualified staff accurately assess children's development and plan a wide range of experiences that helps children to make good progress in their learning. Staff support children's language development particularly well. They consistently model correct pronunciation and full sentences for children who are younger or need more support. Older children thoroughly enjoy taking part in the listening game and confidently describe the different sounds they hear. Children quickly engage in creative tasks on their own or with their friends. Younger children use construction toys imaginatively, for example, to build a home for their dinosaurs. Within the baby room, staff ensure that children have the opportunity to develop sensory skills, for example, they explore coloured corn flour and water.

Personal development, behaviour and welfare are outstanding

Children demonstrate excellent levels of confidence as they make choices from the extensive play and learning resources available indoors and outdoors. Children's behaviour is exemplary. They play incredibly well together and show exceptional care for others. Staff use consistent approaches to reason with and explain to children the right way to behave. Children have excellent opportunities to be physically active and to take manageable risks and challenges to help them gain important skills. Supervision of children is highly effective. Children benefit from a well-balanced diet which promotes their good health. In addition, they grow fruit and vegetables in the nursery's allotment area and discuss healthy foods to eat. Staff provide a vast range of experiences that help children explore different cultures and faiths and to understand the diversity of the world around them. For example, children have recently been involved in a project to send their unwanted toys and clothes to under privileged children living in Bangladeshi.

Outcomes for children are good

Children are very curious, highly motivated and eager to learn. They develop an awareness of colours, number and size during activities. Older children are successful at learning to do things for themselves, such as putting on outdoor clothes and serving themselves at mealtimes. All children, including those in receipt of funding, make good progress in their learning. They learn key skills in readiness for their eventual move on to school.

Little Acorns Nursery registered in 2011. The nursery employs 11 members of childcare staff. Of these, 8 hold appropriate early years qualifications at level 3 or above, including two with early years degrees. The nursery opens from Monday to Friday all year round. Sessions are from 7.30am until 6pm. The nursery provides funded early education for two-, three- and four-year-old children.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register.
