## Summary of key findings for parents

### This provision does not meet requirements

- The provider, who is also the manager, fails to ensure that necessary records and documents are kept up to date and made easily available for inspection.
- The provider fails to ensure robust vetting, recruitment and induction procedures are in place, to assure staff's overall and ongoing suitability.
- The provider and staff do not make accurate assessments of children's development or plan suitably challenging activities that help to promote their good progress. They do not complete the progress check for children aged between two and three years.
- The provider does not gather enough information from parents about what their child already knows and can do when they first start at the setting.
- The provider ensures children can play in a safe environment. Risk assessments and daily checks ensure that hazards are minimised.
- The provider ensures children's health and welfare by maintaining appropriate medication records, offering children a healthy, balanced diet, and by ensuring that at least one member of staff has completed food hygiene training.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

## What the setting needs to do to improve further

#### The provision is inadequate and Ofsted intends to take enforcement action:

The Den registered in 2017 and is located in Burbage, Leicestershire. The setting employs four members of childcare staff. Of these, three hold appropriate early years qualifications at level 3. The setting opens from Monday to Friday all year round. Sessions are from 7.30am until 6pm. The setting also offers before- and after-school care as well as holiday care.
