Summary of key findings for parents

The provision is inadequate

- Leadership and management are weak. They fail to ensure that staff complete daily safety checks effectively. As a result, children are exposed to hazards in the outdoor area. Additionally, resources left on the floor pose a trip hazard to children and staff.
- Staff do not effectively share updated information about children's dietary requirements. This means that children's health is put at risk.
- Staff do not ensure that the arrival times of the children are recorded accurately. This demonstrates poor practice, and compromises the effective management of the provision.
- Management does not implement effective induction procedures. Staff do not understand their duties or obtain a secure knowledge of wider safeguarding issues. This does not fully support children's welfare.
- Supervision procedures remain ineffective, despite this being raised as an action at the last inspection. Staff receive minimal support or guidance in their role to help them improve their practice.
- The quality of teaching, including the planning of activities, is poor across the nursery. Consequently, children do not make good enough progress in their learning.

It has the following strengths

■ Children are settled and form warm relationships with staff, therefore, supporting their emotional well-being.

What the setting needs to do to improve further

The provision is inadequate and Ofsted intends to take enforcement action:

Inspection activities

- The inspectors observed the quality of teaching, general play and routines during activities indoors and outdoors, and assessed the impact this has on children's learning.
- The inspectors talked with the staff and children at appropriate times throughout the inspection.
- The inspectors completed two joint observations of teaching and learning with the manager and the area manager. They held joint discussions with the management team in relation to observations of the children's play, learning and progress.
- The inspectors held a meeting with the management team. They looked at relevant documentation and evidence of the suitability of staff working at the nursery.
- The inspectors spoke to several parents during the inspection and took account of their views.

Inspection findings

Effectiveness of leadership and management is inadequate

Standards in the nursery have deteriorated. Since the last inspection, there have been further changes in the staffing structure. The new management team is beginning to identify weaknesses in the operation of the nursery and staff practice. However, it has failed to implement improvements swiftly enough to raise the quality of care and learning. For example, despite a visit from Ofsted in the summer, staff still lack sufficient knowledge of wider safeguarding issues. Safeguarding is not effective. Staff do not complete the required risk assessments of the outdoor area to ensure it is well prepared and safe for children to play in. On the day of inspection, a divider fell onto a young child while they were playing in the garden. Staff deployment in the large pre-school room is disorganised. Staff fail to communicate with one another and, as a result, children's needs are not effectively met. Leaders initiate meetings with staff to discuss their work. However, this is having little impact on the overall quality of teaching. Appropriate recruitment procedures are in place to ensure new staff are suitable. Staff know how to refer concerns about children's welfare should they have a concern.

Quality of teaching, learning and assessment is inadequate

The quality of teaching across the nursery is poor, and children do not make good enough progress. For example, staff in the pre-school room ask mundane questions, and do not challenge children's thinking. As a result, children are not actively involved in purposeful activities that extend their knowledge and ideas. Older children quickly lose interest and run around, which means noise levels rise. Staff are beginning to make observations and assessments of the children. However, this information is not effectively used to plan and support children's individual developmental needs or help them to address any gaps in their learning in a timely manner. Nevertheless, children demonstrate that they enjoy their time at the nursery. The more experienced and qualified staff demonstrate an ability to follow children's interests. For example, in the garden, children pretend to walk the plank on a pirate ship. This results in staff encouraging children to make a sail for their ship and to sing songs about the ocean, supporting their imaginative skills. Staff sing to children across the nursery, which supports children's developing language skills.

Personal development, behaviour and welfare are inadequate

Breaches of the statutory requirements compromise children's welfare, and their learning and development. Children have access to a range of age-appropriate resources. However, this is not effectively organised to sustain the children's enjoyment and safety. Staff carry babies over areas where toys are tripping hazards. Young babies are able to pull heavy wooden items from the shelf and older children access the toilets close to a staircase unsupervised. The procedure for updating any changes to information about children's dietary needs is ineffective. This means not all staff and leaders know about all children's allergies and intolerances. This poses a risk to children's health. Information about children's daily care is exchanged between staff and parents, supporting children's daily routines. Children are physically active and enjoy regular opportunities to experience outdoor play. They have opportunities to move their bodies in a variety of ways. For example, they climb up the steps of the slide and walk on balance beams.

Outcomes for children are inadequate

Children are not provided with appropriate, challenging and inspiring activities to meet their individual learning needs. Weaknesses in the overall quality of teaching mean that children do not make the best progress towards the next stage of their learning. Children do not always receive the support from staff they need. For example, they give up on learning new skills, such as putting on their own coats, particularly when they receive little support or encouragement.

Of these, 19 hold appropriate early years qualifications at level 2 or above, including three with qualifications at level 6. The setting opens Monday to Friday from 7am until 7pm.
