This provision meets requirements

- The manager and staff have a clear understanding of safeguarding issues. They are able to explain issues that may compromise children's welfare and know how to report concerns.
- The manager and staff explained how they access risks to the premises and the activities children participate in. This supports them to ensure children remain safe.
- Records are well maintained, readily available and support the safe and effective management of the provision.
- Staff effectively plan a range of activities. They understand how to include younger children when playing alongside the older children in the group.
- The manager and staff understand the importance of supporting the needs of children and promoting their emotional security.
- Staff recognise the importance of helping children to develop healthy lifestyles. For example, they actively plan a wide range of outdoor activities each day and promote a healthy diet.
- Through discussion, the manager and staff confidently discuss strategies to manage children's behaviour. For example, they support children to take their turn during group games and to be considerate to their friends.
- The manager and staff recognise the importance of working in partnership with parents and staff at the school to help provide continuity of care for children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector had a tour of the premises, indoors and outdoors.
- The inspector made observations of the staff and their interactions with older children while involved in various activities.
- The inspector looked at relevant documentation, including risk assessments, children's records, a range of policies and procedures.
- The inspector reviewed evidence of the suitability of staff working in the provision.
- The inspector considered the views of parents in discussion during the inspection.
