This provision meets requirements

- The childminder demonstrates a good understanding of how to keep children safe. She attends training to keep up to date with changes in legislation.
- The childminder understands the value of professional development and evaluating her practice. For example, since the last inspection she has introduced a robust system for tracking children's progress.
- The childminder knows how to plan interesting activities and outings to support children's learning and development.
- The childminder is aware of the importance of teaching children about healthy lifestyles by, for example, eating a balanced diet and playing outside in the fresh air.
- The childminder is able to explain how to support children to be independent. She understands how to manage children's behaviour, teaching them to share and be kind to each other.
- The childminder understands the importance of partnership with parents and other professionals to provide children with continuity of learning and care.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
