# **Summary of key findings for parents**

## The provision is good

- Staff offer a welcoming and inclusive learning environment where children feel safe and secure. Children settle well into daily routines and play together in harmony. Their behaviour is good.
- Managers and staff check the progress of each child and groups of children. When identifying gaps in children's learning, they provide good support to help children to narrow these. Children make good progress in relation to their different starting points. Staff prepare children well for the next stage of their learning, including starting school.
- Children develop good knowledge of how to keep themselves safe. For example, children know it is safe to cross the roads, using 'zebra crossings' and 'traffic lights' during role-play activities and outings.
- Staff build positive relationships with parents and keep them well informed about their children's learning and development. They involve parents in planning children's next steps in learning.
- Managers have successfully improved their practice. For example, they monitor and evaluate the provision to help improve many aspects of teaching and outcomes for all children.

## It is not yet outstanding because:

- On occasions, staff do not consistently help children to manage tasks for themselves to become more independent in their learning.
- Staff do not always provide further opportunities for children to access and develop their skills in using everyday technology.

## What the setting needs to do to improve further

#### To further improve the quality of the early years provision the provider should:

- encourage children to manage more tasks themselves so that they can increase their independence
- broaden the range of opportunities to help children access and develop their skills in using information and communication technology.

#### **Inspection activities**

- The inspector observed activities in all parts of the nursery, including the outdoor provision.
- The inspector spoke to staff and children at appropriate times during the inspection and held meetings with the management team.
- The inspector carried out joint observations with the manager.
- The inspector took account of the views of parents spoken to during the inspection and reviewed parents' written comments and suggestions.
- The inspector looked at children's records, planning documentation and the nursery's policies and procedures, including those related to the suitability of staff.

## **Inspection findings**

#### Effectiveness of leadership and management is good

Safeguarding is effective. Robust recruitment processes help ensure that all staff are suitable to work with the children. The provider now ensures that committee and management are suitably checked by Ofsted and is clear of the requirement to notify Ofsted in a timely manner. Managers and staff have a good understanding of safeguarding practices to protect children in their care. Managers observe and coach staff to help them improve the quality of their practice. Staff attend courses to improve their teaching. This is evident in the way they review their planning and group activities to help children remain interested in play and to achieve well. Strong links with the feeder schools and relevant agencies helps to support a continuous approach to children's care and learning. Managers and staff welcome parents and others' opinions and act on them quickly to improve their service.

## Quality of teaching, learning and assessment is good

Staff gain relevant information from parents to assess their children's learning. They observe children in play and use such information to provide a good overall range of engaging activities. Staff interact well with children and play with them. Children are well motivated to learn and try new activities. For example, children eagerly decorate dried pasta shapes with different coloured paints and glitter to give them an artistic effect. Young children like to mould, pat, roll and cut playdough into different shapes and respond well to staff's praise. Staff introduce children to songs and books. Children enjoy singing, learn new rhymes and keenly share ideas about their favourite pictures and events.

#### Personal development, behaviour and welfare are good

Staff are good role models for the children. For example, they share their behaviour rules with children so that they know what is expected. Children know they need to use 'gentle hands' and 'kind voice' when they play with their friends. Staff help children learn about living a healthy lifestyle. For example, children know that water keeps them hydrated. They wash their hands before meals to reduce the risk of infection. Children enjoy physical activities. For instance, they learn to move their bodies in different ways and can hop and jump into hoops safely. Staff conduct daily checks on the premises and resources to keep children safe.

## Outcomes for children are good

All children make good progress and any gaps in their learning are closing. Young children love to explore tools and to find out how things work. Older children know some letters and the sounds they represent and recognise their names. They sort and match objects and learn about directions. Children are aware of the changes that happen to the natural world around them.
