Summary of key findings for parents

This provision does not meet requirements

- The childminder does not understand the early years register assessment requirements. As a result, she does not know how to complete the progress check for children between the ages of two and three years or how to monitor children's development.
- The childminder is familiar with wider safeguarding and child protection issues. She knows the procedures to report any concerns, including allegations, to the relevant authorities.
- The childminder recognises the importance of working with parents to support children's learning and to encourage positive behaviour. She knows how to share information with them about children's needs and interests to extend their learning at home.
- The childminder knows how to plan a range of opportunities for children to enjoy and to help them make progress. For example, she describes how she intends to use stories to develop children's communication and literacy skills.
- The childminder understands how to support children's physical, personal and social development.
- The childminder knows how to obtain feedback from parents and children to help evaluate her practice and children's experiences.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What the setting needs to do to improve further

To meet the requirements of the early years foundation stage and Childcare Register the provider must:

develop an understanding of how to complete the progress check for children aged between two and three years and how to monitor children's development.
