Overall outcome

The school is unlikely to meet all the independent school standards when it opens

Main inspection findings

Part 1. Quality of education provided

All paragraphs

- Leaders have developed curriculum and assessment policies which appropriately consider the needs of pupils who have special educational needs (SEN) and/or disabilities.
- Leaders have developed suitable teaching plans, which cover all the required areas of learning for pupils aged 11 to 16. A teaching team has been recruited to ensure coverage of all curriculum areas, including music, food technology and sports leadership.
- British values and the protected characteristics, as identified in the Equality Act 2010, are planned to be addressed across the curriculum areas, as well as through the appropriately planned personal, social, health and economic (PSHE) education programme.
- Leaders' plans for careers education are likely to be suitable. In addition to a well-planned careers education programme for all pupils, external careers advisers will be commissioned from the local authority to provide impartial information, advice and quidance to pupils in Years 10 and 11.
- An appropriate assessment system has been planned. Pupils' progress, both personal and academic, will be tracked over time using an online system and 'I can' statement banks.
- There are suitable plans to assure the quality of teaching and assessment. The school's consultant, who will support the headteacher two days per week, will lead a thorough monitoring and training cycle for teachers.
- Leaders have ensured that the independent school standards in this part are likely to be met if this school is registered.



Part 2. Spiritual, moral, social and cultural development of pupils

All paragraphs

- Leaders have developed suitable plans which outline a clear commitment to the promotion of British values and to ensuring that pupils learn about all the protected characteristics and develop spiritually, morally, socially and culturally.
- The PSHE programme is comprehensively planned. The programme is likely to ensure that pupils learn about equality, diversity and about a range of religions, cultures and beliefs, including through assemblies, daily reflection and themed events.
- The school's staff handbook makes it clear that no member of staff may promote partisan views and that balanced viewpoints must always be presented in the teaching of all subjects.
- Leaders have ensured that the independent school standards in this part are likely to be met if this school is registered.

Part 3. Welfare, health and safety of pupils

All paragraphs

- The school's safeguarding policy reflects the most recent statutory guidance. It is made available on the school's website. Arrangements for staff induction, training, weekly updates and checks on their understanding are likely to ensure that pupils are kept as safe as possible. The school's proposed system for recording concerns, referrals and any actions taken is appropriate. Online enhanced safeguarding training was booked for designated safeguarding leaders during the inspection. It was completed by the headteacher on 24 August 2018. Another full-time member of staff will also complete this training in order to be able to deputise for the headteacher.
- The school's behaviour and anti-bullying policies are likely to meet requirements. They have been appropriately developed with pupils' SEN and/or disabilities in mind.
- Leaders have written an appropriate first aid policy. During the inspection, evidence to confirm that at least two first aiders have been suitably trained was not available. However, evidence was provided after the inspection that a teacher has completed a three-day first aid training course and that the headteacher is booked to train in first aid on 7 September 2018. However, there is not an appropriate medical room facility that meets all the requirements.
- The school is not likely to be compliant with the Regulatory Reform (Fire Safety) Order 2005. A fire risk assessment had not been completed at the time of the inspection. At this time, the fire extinguishers seen were last checked in 2008 and the fire alarm system had a fault. Fire safety professionals were commissioned to attend the premises in September 2018, which was brought forward to 24 August 2018 as a result of the inspection. Leaders have informed inspectors that the fire safety issues will be resolved as a matter of urgency.
- Leaders have produced an acceptable health and safety policy but had not written a risk assessment policy or undertaken a risk assessment of the premises at the time of the inspection. Following the inspection, both an acceptable risk assessment policy and premises risk assessment were written and shared with the inspector.

- At the time of the inspection, the premises were not ready for pupils. The windows opened too widely, there were plumbing concerns in the toilets and some of the lighting did not work because of a leak. Works to replace lightbulbs, redecorate, furnish, create a safe and secure reception area and declutter some of the rooms were all planned to take place before, and during, September 2018. Some works, according to information provided after the inspection, have been completed, and items such as magnet locks for doors and mechanisms to secure windows have been ordered. However, the information provided is not enough to judge the relevant standards as likely to be met.
- Admission and attendance registers will be kept electronically using the required codes and including the required information.
- Leaders have not ensured that the independent school standards in this part are likely to be met if this school is registered, as listed in the annex to this report.

Part 4. Suitability of staff, supply staff, and proprietors

All paragraphs

- All the required vetting checks for the proprietor, headteacher, staff (including agency staff) and the school's consultant, have been completed and accurately recorded on a single central record of checks, which is likely to meet requirements.
- Leaders have ensured that the independent school standards in this part are likely to be met if this school is registered.

Part 5. Premises of and accommodation at schools

All paragraphs

- The school's premises consist of multiple classrooms and learning spaces across three floors of a building which will also be used at weekends as a place of worship.
- The premises were not ready for pupils at the time of this pre-registration inspection. They were not safe, clean or well maintained. Fire safety was a particular concern.
- A disabled toilet has been allocated as the medical room facility. The toilet facility is not separated, as per the requirements, and there were no bed or medical supplies. However, evidence that medical supplies are now in place was provided after the inspection.
- There is a small outdoor space that will not be available for use for outdoor play until it is cleared of rubbish and made safe.
- There are no changing room or shower facilities. Pupils will access these facilities as part of physical education at local leisure centres.
- At the time of the inspection, some of the internal lighting was not working because of an electrical fault due to a leak. Multiple lightbulbs had blown on all floors.
- It is not known if the hot water supply is adequate or regulated because the boilers were not in operation at the time of the inspection. There were no suitably marked supplies of drinking water.

- At the time of the inspection, there was no reception area and the proposed entrance was not secure. There are plans for a more secure reception area and an intercom system to be installed.
- The acoustic features and sound insulation are suitable.
- Leaders have not ensured that the independent school standards in this part are likely to be met if this school is registered, as listed in the annex to this report.

Part 6. Provision of information

All paragraphs

- All the required policies and information are available on the school's website.
- The school's intended attainment and progress report template is likely to meet requirements.
- Leaders are aware of their duty to provide local authorities with annual statements of income and expenditure for funded pupils with education, health and care plans.
- Leaders have ensured that the independent school standards in this part are likely to be met if this school is registered.

Part 7. Manner in which complaints are handled

All paragraphs

- The school's complaints procedure, outlined in a clear complaints policy, is likely to meet requirements.
- Leaders have ensured that the independent school standards in this part are likely to be met if this school is registered.

Part 8. Quality of leadership in and management of schools

All paragraphs

- There are suitable arrangements for the long-term leadership and governance of this school. However, even with the additional information provided after the inspection, the school is not ready to admit pupils.
- All the independent school standards are not likely to be met and pupils' well-being is not likely to be assured if Serenity School is registered as an independent school at this time.

Information about this proposed school

- Serenity School intends to register as an independent special day school in the London Borough of Croydon. It is not currently operating and has never done so.
- The school intends to offer day places to boys aged 11 to 16 who have a range of SEN and/or disabilities.
- The school intends to open in September 2018.
- The school will be led by a headteacher and the proprietor who will fulfil the role of deputy headteacher. A governing body has been formed.
- Leaders do not intend to make use of alternative provision.



Information about this inspection

- This is the school's first pre-registration inspection.
- The inspection was carried out under section 99 of the Education and Skills Act 2008, the purpose of which is to advise the Secretary of State for Education about the school's likely compliance with the independent school standards that are required for registration as an independent school.
- The inspection was conducted with two days of notice.
- The inspector conducted the inspection with the proprietor, chair of governors and a consultant.
- The inspector considered a wide range of evidence to check the likelihood of the school meeting all of the independent school standards. As examples, he toured the premises, reviewed key documents and policies and considered the school's proposed curriculum.
- The inspector took account of additional information provided via email to the inspection administrator after the pre-registration inspection visit.
