Summary of key findings for parents

This provision is good

- Children form friendly relationships with the staff and freely seek their help when they need it. They develop a good understanding of the routines at the club, and know what is expected of them. Children are settled and happy.
- Staff provide opportunities for children to celebrate seasonal festivals that reflect different faiths and traditions. Children are respectful of each other and value differences.
- Staff complete thorough risk assessments to ensure children's safety. They deploy themselves well and supervise children effectively as they move between different areas of the environment. Children feel safe, which helps them to build on their confidence.
- Self-evaluation is effective. The management team has successfully met the actions and recommendations set in the previous inspection. They support staff well through regular supervision, ongoing support and professional development opportunities, to provide good levels of care for the children.
- Staff do not always provide consistent opportunities for younger children in the group to access resources easily during some activities, to help support their continued enjoyment as they play.
- Staff have not considered ways to make best use of everyday opportunities to help children extend further on their self-help skills.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- provide consistent opportunities for younger children in the group to access resources easily during activities, to help support their continued enjoyment as they play.
- make best use of opportunities to fully support children to build on their self-help skills.

Inspection activities

- The inspector observed the children and how staff interacted with them.
- The inspector held discussions with the managers and staff at appropriate times.
- The inspector took account of the views of parents and children.
- The inspector observed an activity with the manager and assessed the effectiveness of performance management.

Inspection findings

Effectiveness of leadership and management is good

The managers reflect well on their practice. They review the policies and procedures regularly and make positive changes; for instance, to strengthen the arrangements for children's safety at collection time. Staff act as a link between the school and the parents, and pass on information that the teachers share with them. This helps to support continuity in children's care and experiences. Safeguarding is effective. Staff understand how to identify signs and symptoms that indicate concerns for children's welfare. The managers and the staff team work well together to monitor how younger children in the group settle in and they support their emotional well-being well.

Quality of teaching, learning and assessment is good

Staff take account of children's views to plan activities that help to stimulate their interests. Parents and children express positive views about the range of art and craft activities that staff provide. Staff tune in well to children's play ideas. For instance, when children choose to play with toy models of ponies, staff provide brushes for them to tidy the pony's mane. Staff provide opportunities for children to explore the use of technology. For instance, children enjoy using controls to move images on the screen. Staff skilfully engage children in activities that help them to extend their counting skills. While playing a board game, children learn to count the dots on a dice and staff show them how to move the counters correspondingly. These activities help to complement what children learn at school.

Personal development, behaviour and welfare are good

The management team has reviewed the meal menus to include healthy options, such as vegetables. They ensure that drinking water is available within children's access. They have made effective changes to the organisation of tea time to minimise waiting times for children. Staff provide regular opportunities for children to be physically active. For instance, children enjoy running around with their friends in the outside area and explore skills, such as jumping in and out of a row of hoops. Younger and older children play cooperatively with each other and share responsibilities well; for instance, to tidy up resources after play. Staff encourage their good behaviour with praise. Children develop positive self-esteem. They are confident and enjoy sharing their experiences with others.
