# Summary of key findings for parents

## This provision is outstanding

- The manager is highly reflective. She makes excellent use of tracking children's progress and monitoring staff performance to make precise improvement plans towards the high quality of the provision.
- Staff share comprehensive information with parents about children's needs and achievements. They plan meticulously towards children's developmental needs.
- Staff place an extremely sharp focus on helping children to acquire excellent communication and language skills. They make the best of every opportunity to encourage children to share their own knowledge and experiences.
- The quality of teaching is inspirational and highly responsive to children's individual needs. Children make excellent progress from the moment they join the preschool, including those with special educational needs and/or disabilities.
- Staff promote high standards of hygiene practice. Children learn to wash hands after coughing to prevent the spread of infection.
- Children behave extremely well. They are kind and polite to each other and engage in play exceptionally well.

# What the setting needs to do to improve further

#### To further improve the quality of the early years provision the provider should:

■ continue to strengthen the already excellent opportunities for children to express themselves freely through an extensive range of media and materials.

## **Inspection findings**

#### Effectiveness of leadership and management is outstanding

The highly qualified and experienced manager and staff team go above and beyond their roles to support families and children. The manager secures timely interventions and offers exceptional support for children and their families. She is highly effective at monitoring staff practice. She makes excellent use of staff observations to review each role and make precise planning towards professional development plans. She accesses training and advice from local professionals to enhance staff's knowledge and skills to the highest levels. Safeguarding is effective. The manager and staff have an excellent understanding of how to identify and report any concerns about a child's welfare.

## Quality of teaching, learning and assessment is outstanding

Staff make excellent use of research and implement their new learning into their planning. For example, raising the already excellent opportunities for children to extend their physical skills. Children challenge themselves to carefully thread different objects on to string. Staff use highly effective questioning techniques to encourage children to think and discuss their ideas. Children think about how to stop the objects falling off of the string. Staff encourage them to learn through trial and error. Outside, children try to use a colander to carry water and discover the water leaks through the holes. Staff constantly challenge children's mathematical development. They challenge them with adding and subtraction to extend their understanding of numbers even further.

## Personal development, behaviour and welfare are outstanding

Staff provide a highly stimulating environment that fully engages children in play. Staff are highly skilled at supporting children's well-being. They are extremely sensitive and meet children's needs exceptionally well. Children arrive happily and greet staff with big smiles and cuddles. Staff form excellent relationships with other settings that children attend to provide excellent consistency in children's learning. They go on school visits with parents to share comprehensive information with new teachers.

## **Outcomes for children are outstanding**

Children are extremely well prepared towards their next stages in development, including the move to school. Children enjoy writing for a purpose, such as labelling pictures with their names. They show high levels of independence and self-care. Children prepare their own snacks and pour their own drinks. Children show high levels of confidence as they socialise well with each other and visitors. Children are highly motivated, confident and eager to learn.

Greatworth Pre-School was re-registered in 2016 and is located at the rear of Greatworth Primary School, Greatworth. The pre-school is open Monday to Friday during term times from 8.30am to 3.30pm. The pre-school receives funded early education for children aged three - and four - years - old. There are four members of staff employed to work with the children. Of these, the manager has an appropriate early years qualification at level 6, and the three other members of staff have appropriate early years qualifications. The setting supports children with special educational needs and/ or disabilities.
