Summary of key findings for parents

This provision is good

- The childminder is committed to professional development and is currently studying towards a level three qualification to further her knowledge. She also makes good use of training opportunities to help her meet the needs of children as effectively as possible. She is a member of a local good practice network, which she uses to evaluate and enhance her provision.
- The childminder uses praise and encouragement well. She effectively supports children's self-confidence and self-esteem. Children are proud of their achievements and encourage visitors to look at their paintings.
- Children have formed strong friendships with each other and the childminder supports their social skills effectively. She is a positive role model for children and encourages them to play nicely together and follow the rules of her setting.
- The childminder knows what children like and accurately assesses their development. She provides activities that she knows they will enjoy and monitors their overall development, to identify and address any gaps in learning.
- The childminder does not plan meticulously enough, particularly for those children who prefer to learn outdoors, to support their learning as effectively as possible.
- The childminder does not always make effective use of outdoor play opportunities to help children understand how to identify and manage risks independently to keep themselves safe.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- plan activities more meticulously, including those children who prefer to learn outdoors, to promote the best possible outcomes in their learning
- enhance children's understanding of how they can help to keep themselves safe.

Inspection activities

- The inspector had a tour of the areas of the premises used for childminding purposes.
- The inspector jointly evaluated an activity with the childminder.
- The inspector observed activities indoors and outdoors. She evaluated the impact of teaching on children's learning.
- The inspector spoke with the childminder and children at appropriate times. She sampled documents, including children's records and evidence of the childminder's suitability and qualifications.

Inspection findings

Effectiveness of leadership and management is good

Safeguarding is effective. The childminder knows how to identify abuse and the correct local procedures to report it. She undertakes regular training to refresh her knowledge and understanding, including wider child protection issues. Her setting is secure and rigorously risk assessed to help keep children safe. The childminder has made links with other local childminders and accesses support from the local authority and other professionals to enhance her practice. She works well in partnership with parents and other settings that children attend, sharing information regularly and promoting continuity of care. The childminder also understands the importance of engaging with other professionals to address any gaps in children's learning.

Quality of teaching, learning and assessment is good

The childminder understands how children learn and has appropriate expectations of children's capabilities, based on her accurate assessments. She provides a broad range of activities and experiences that supports children's development in all areas of learning. Young children learn how to operate simple electronic toys and enjoy exploring cause and effect. For example, all children lie on their backs and blow pieces of fabric into the air. The childminder encourages them to estimate who can blow the fabric the highest. Children enjoy going outdoors and demonstrate good balance and coordination as they climb on small apparatus. Children thoroughly enjoy listening to the childminder read a story. They join in, answering her questions and guessing what will happen next.

Personal development, behaviour and welfare are good

Children are very happy and confident. They interact well with each other and the childminder supports their understanding of turn taking effectively. She has created a welcoming atmosphere and children are encouraged to be themselves. The childminder helps children to accept differences and learn more about the world around them. They all follow hygiene procedures to minimise the risk of cross-infection and select their own fruit for their snack. The childminder gives children time to try things that they find challenging, such as peeling a tangerine or putting on their own shoes. Children understand what the childminder expects of them and readily follow her instructions.

Outcomes for children are good

All children make good progress from their individual starting points. They develop a range of key skills that prepares them for their future learning. Older children correctly identify their name written on a card, with and without their photograph. Some children can identify written numbers and use these in their play. Children enjoy learning. They are curious and motivated to learn as they explore the range of resources and activities available.
