- The childminder understands the procedures to follow should she have any concerns about a child's welfare.
- The childminder understands how to manage children's behaviour successfully, and to teach them to respect others.
- The childminder understands how to reflect on her practice and build ongoing improvements.
- The childminder understands how to assess children's learning and provide interesting, suitably challenging activities to ensure they make good progress.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The childminder registered in 1999. She lives in Epsom, Surrey. The childminder is available to provide care for children on each weekday from 8am until 6pm, all year round except for public holidays. The childminder holds a childcare qualification at level 3.
