Summary of key findings for parents

This provision is good

- Staff provide an environment that is nurturing and welcoming. They successfully foster children's emotional well-being. Children are extremely happy, confident and motivated to play and explore.
- Children's understanding of a healthy lifestyle is successfully promoted. They are provided with healthy snacks, drinks and nutritious meals. Children follow good hygiene routines, such as washing their hands prior to eating.
- Staff form positive relationships with parents. Parents comment that they are happy with the service provided. Children look forward to attending the club.
- Staff provide stimulating environments with a good variety of accessible resources. This enables children to choose what and how they want to play.
- Children have strong bonds with staff and happily approach them for support in their play. Children make friendships across the age groups.
- Staff do not collate enough information from teachers about children's interests and progress to ensure these are fully complemented in the activities at the club.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- extend the range of information collated from teachers about children's interests and progress to further complement and enhance their play and learning experiences.

Inspection activities

- The inspector observed and assessed the quality of staff's interactions with children during activities indoors.
- The inspector spoke with staff and children during the inspection.
- The inspector held a meeting with the club manager and provider. She looked at relevant documentation and evidence of the suitability of staff working in the club.
- The inspector spoke to a small number of parents during the inspection and took account of their views.

Inspection findings

Effectiveness of leadership and management is good

The arrangements for safeguarding are effective. Staff are aware of the procedures to follow if they have concerns about a child's welfare. They monitor children's safety well. Children learn to understand potential risks as staff offer clear safety explanations. The views of parents, children and staff are valued. The provider considers their comments when evaluating the quality of the service and uses their feedback to plan and make positive improvements. Staff have opportunities to review their practice. Together with the provider, they identify their professional development needs and plan training to enhance and strengthen their skills and practice.

Quality of teaching, learning and assessment is good

Staff provide an inviting environment and a wide range of well-organised activities. Indoors, children enjoy playing with a good selection of high-quality toys and resources. They join together to play table tennis and enjoy rolling and chasing hoops. Children engage in table-top games and use small-world resources. Other children construct with magnetic shapes or spend time drawing and colouring. Staff are warm and friendly and show a strong interest in what children do and say. They talk to children, ask questions and encourage them to share their thoughts, helping to build on their language skills. Key persons gather important information from parents before children start at the club. This includes information about children's preferences, likes and dislikes. They make good use of this information to support new children to settle.

Personal development, behaviour and welfare are good

Staff are kind, friendly and welcoming. They ensure children's similarities and differences are celebrated and valued. Children are generally self-assured and settled in their surroundings. Children of all ages know what to expect during sessions as staff share clear boundaries and follow consistent practices. This supports children to behave well. Children are happy and say they enjoy attending the club. They learn about the importance of adopting a healthy lifestyle. Children enjoy a very good range of healthy snacks and enjoy being active. They receive consistent support for their care needs.

Village Hideout registered in 2011. The club employs five childcare practitioners. Of these, three hold appropriate early years qualifications at level 3. The club opens Monday to Friday during term time only. Sessions are from 7.15am until 8.50am and 3.30pm until 6pm.
