Summary of key findings for parents

This provision does not meet requirements

- Children's safety is not assured. Staffing arrangements do not ensure that the needs of all of the children are met. The manager has not considered adequate methods to ensure children receive appropriate supervision when they are present.
- Staff do not take steps to ensure that they are fully aware of who has parental responsibility for children in their care.
- While risk assessments have been completed for most aspects of the provision, the manager has not completed a risk assessment relating to the transportation of children from school in her car. This also includes ensuring that the correct car seats are provided.
- The manager and staff do not complete records when medicines are administered to children. As a result, parents are not made aware of when medicines have been given.
- The manager has satisfactorily addressed actions raised at a previous visit.
- The manager communicates with parents daily. Staff take steps to ensure messages from school are shared with parents when they collect their children. Parents are happy with the service they and their children receive.
- Children engage in a variety of age-appropriate activities. Staff plan each week considering the children's ideas and interests. Resources are plentiful and well-maintained.
- Children are encouraged to share and take turns with the toys. Staff support their awareness of what is acceptable behaviour. Children play an active role in devising the rules for the club. Staff recognise and praise children for their good behaviour.
- The manager and staff demonstrate a clear commitment to continually developing the club. They seek and act on the views of parents and children and use these to inform self-evaluation.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What the setting needs to do to improve further

To meet the requirements of the early years foundation stage and Childcare Register the provider must:

Kidz Come First registered in 2016. The club opens term time only from 3pm until 6pm Monday to Friday. The club also operates a playscheme during school holidays from 8am until 6pm Monday to Friday. The club employs four members of childcare staff, of whom two hold appropriate qualifications at level 5 and 6.
