Summary of key findings for parents

This provision meets requirements

- The childminder has completed safeguarding training and understands her responsibility to implement her written safeguarding procedures to protect children's care and welfare. She holds a paediatric first-aid certificate and knows the importance of continuous professional development to help improve the quality of her practice.
- The childminder knows to carry out risk assessments on her home and garden and when taking children out on outings. She understands the importance of providing children with a safe environment in which to play and learn.
- The childminder understands how to use the information gained from her observation and assessments procedures. She knows how to support children's next steps in learning, monitor their progress to help them acquire skills in readiness for school.
- The childminder understands the benefits of providing children with daily opportunities to be physically active. She knows to plan activities that help children learn about the importance of healthy eating to maintain their good health.
- The childminder recognises the importance of working in partnership with parents and other professionals. She understands the need to share regular information to help provide a consistent approach in meeting the needs of all children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector held discussions with the childminder about the safeguarding requirements and children's learning and development.
- The childminder sampled a range of documents including the suitability of adults living in the home, safeguarding procedures and her paediatric first aid certificate.
- The inspector viewed all areas of the home used for childminding and sampled risk assessments.
- The inspector discussed with the childminder how she intends to evaluate the effectiveness of the service she provides to bring about further improvement.
- The inspector discussed with the childminder the importance of working in partnerships with parents, other providers and professional agencies.
