Summary of key findings for parents

This provision meets requirements

- The childminder knows how to support children's awareness of healthy lifestyles, for example, through healthy eating, regular exercise and following hygiene procedures.
- The childminder describes how she will promote children's learning and development. She knows how to support and motivate children through a range of play experiences, based on their interests.
- The childminder understands her responsibility to observe, track and assess the progress children make. She describes how she will work with parents to promote continuity of children's care and early education.
- The childminder knows how to manage children's behaviour and how to help children become confident and emotionally secure in her care.
- The childminder describes how she intends to extend her professional development and how this will help her to make continual improvements to her practice.
- The childminder has a confident knowledge on how she can safeguard children. She knows how to notice if a child's welfare is at risk and is aware of procedures to follow if a concern arises.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed the childminder's knowledge of the early years foundation stage requirements.
- The inspector discussed the childminder's understanding of children's development and the educational programmes she intends to deliver.
- The inspector checked suitability documents, including the childminder's first-aid and insurance certificates.
- The inspector viewed the areas of the home to be used for childminding and discussed safety arrangements.
- The inspector sampled required documentation and discussed how the childminder would use these records to support children's well-being.

The childminder registered in 2016 and lives in Frimley Green, Surrey. She provides childcare Monday to Thursday for most of the year.
