Summary of key findings for parents

This provision meets requirements

- The childminder has improved her practice since the last inspection and addressed the actions and recommendation raised. This demonstrates a commitment to improvement.
- The childminder understands how children develop and is aware of the importance of observation and tracking to help children gain the skills needed for their next steps.
- The childminder has attended training to improve her knowledge and skills further in the key areas of learning, to help support children's ongoing developmental progress.
- The childminder understands her role and responsibilities to safeguard children. She has a safe, clean and suitable home which supports children's well-being and health.
- The childminder is aware of how to manage children's behaviour and build their confidence.
- The childminder understands the importance of working in partnership with parents and other professionals involved in children's care and education to support continuity.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The childminder registered in 2012. She lives in Yateley, Hampshire. The childminder operates her service from 7am to 6pm on Monday to Friday, for most of the year, except for family holidays.
