## Summary of key findings for parents

#### This provision is inadequate

- Staff do not have sufficient understanding of their safeguarding responsibilities. Some staff do not have the necessary knowledge to enable them to identify if a child is at risk of harm. Other staff are unsure of what they should do next if they need to escalate any concerns. This poor understanding puts children at risk.
- The manager has not established effective systems for monitoring and improving staff practice. Staff are not consistently effective in helping children to build further on skills they are developing elsewhere.
- Staff have too low expectations of what children can do. They often complete tasks for children that they are capable of doing for themselves.

#### It has the following strengths

- Children show that they are happy to attend the club and that they enjoy playing with their friends.
- Staff encourage children to enjoy the benefits of an active lifestyle. For example, they provide children with a range of bats, balls and ropes outside and encourage them to use them to develop their hand-to-eye coordination.

## What the setting needs to do to improve further

#### The provision is inadequate and Ofsted intends to take enforcement action:

# **Inspection findings**

#### Effectiveness of leadership and management is inadequate

Safeguarding is not effective. The manager has not taken effective steps to make the necessary improvements to staff's safeguarding understanding. For example, although she has provided training for a recently appointed member of staff, she has not checked to ensure that her learning from this is sufficient. This member of staff's safeguarding knowledge remains poor. Other staff are not sure what they should do if they need to share concerns beyond their manager or her deputy. They are unaware that they can refer to the provider's policy to find out what they should do. There have been some improvements since the last inspection. For example, staff now check that resources are safe for children to use and the manager checks staff's ongoing suitability. The provider has made the necessary information available to Ofsted so that the suitability of committee members can be checked. Self-evaluation is ineffective. For example, the manager has not identified that the steps she has taken to improve staff's safeguarding knowledge put children at risk. Parents speak warmly of the staff and report that staff keep them informed about their child's well-being.

#### Quality of teaching, learning and assessment is inadequate

The manager has not taken effective steps to raise staff performance. She has yet to introduce one-to-one meetings where staff can discuss their performance and any confidential matters. However, she has plans to do so. Although she has begun to observe staff, to monitor practice more closely, she has not yet given staff feedback on what she has seen. Staff continue to have a poor understanding of how children learn and develop. Any training they have received has not had a significant impact on their understanding and practice. For example, staff have assessed that younger children do not have the skills to pour their own drinks without spilling. Instead of helping them to develop the control to complete this age-appropriate task, staff remove the cups and pour the drinks for the children. Staff invite children to make Christmas decorations. They provide children are doing if it does not match the instructions in the book of crafts they are using. Children are unable to see the book for themselves due to where it is positioned on the table. However, children enjoy playing with the toys that are available. Staff help them to complete puzzles and follow the rules of table football.

#### Personal development, behaviour and welfare are inadequate

The provider and manager do not assure children's welfare due to the weaknesses in safeguarding practice. However, children are polite and generally well-behaved and tell visitors that they enjoy attending the after-school project. Staff are kind and friendly towards the children. They ensure that there is always drinking water available and plan and provide a range of healthy and nutritious snacks. They follow suitably rigorous procedures to respond to accidents. They obtain written permission from parents before administering any prescribed medication.

St. Thomas Aquinas After School Project registered 1995. It operates from 7.30am to 8.45am and from 3pm to 6pm during term time, and from 8.30am to 6pm in the school holidays. There are seven members of staff, three of whom hold appropriate early years qualifications at level 3 and one holds an appropriate early years qualification at level 5.
