Summary of key findings for parents

This provision does not meet requirements

- The manager does not keep an accurate daily record of children's hours of attendance at the club. This is a breach on the Early Years Register and Childcare Register.
- The manager knows that staff should attend safeguarding training and must be aware of the procedures to report any concerns, including allegations.
- The manager understands how to provide interesting indoor and outside opportunities for children to enjoy and to support their development at the club.
- The manager recognises the importance of forming relationships with parents and other providers that children attend, to share information about children's care and learning.
- The manager understands how to support children to develop their physical, personal and social skills. She knows how to set boundaries to teach children right from wrong.
- The manager knows how to obtain information from parents, children and staff to help evaluate the club. She recognises the benefit to maintain staff's professional development to keep their skills current.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What the setting needs to do to improve further

To meet the requirements of the early years foundation stage and Childcare Register the provider must:

Whitehall Connections After School Club registered in 2014. The club is situated within Whitehall Primary School in Chingford, within the London Borough of Waltham Forest. The club operates Monday to Friday, from 3.20pm to 5.30pm, term time only. The after-school club has six staff including the manager. Of these, three staff hold early years qualifications at level 3 and 2.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
