Summary of key findings for parents

This provision does not meet requirements

- The manager does not have fully effective recruitment systems. Although staff have Disclosure and Barring Service checks, she does not seek references or other information about staff's suitability as required.
- Staff supervision and coaching are not effective enough. Staff do not receive clear feedback on their teaching practice or appropriate opportunities to update their knowledge.
- The manager has failed to notify Ofsted of changes to contact information.
- Self-evaluation is not fully effective to identify the key areas for improvement.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
