Information about this children's home

This home is able to care for up to four children. Its statement of purpose states that the home's policy is to consider children, irrespective of gender and aged between eight and 17, who are having trouble in their lives and who would benefit from the placement.

The home has a manager who was registered on 22 August 2018.

This inspection

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged requires improvement to be good at the last full inspection. At the interim inspection, Ofsted judges that it has improved effectiveness.

There have been a number of improvements since the last inspection. The home now has a registered manager and a deputy manager. This means that there is more capacity for providing effective oversight and guidance. The manager has developed systems for regular quality assurance of recording and key-work sessions so that the staff can improve their practice for the benefit of the children.

The children are making good progress at this home. One social worker said: 'The progress has been absolutely amazing. Staff are creative and think outside the box.' Children are settled and happy and they are having positive experiences. One child went to a premier league football match to celebrate his birthday. This was an excellent

experience that he recounted in great detail and with a lot of pleasure.

Children relate well to the staff and enjoy playing board games and having individual attention. They are all receiving education. Their health needs are well met, and they are having lots of opportunities to develop their social skills. Staff are involved in transporting two children to two schools that are a considerable distance from the home in order to maintain consistency for the children concerned.

The arrangements for medication are not as robust as they should be and there have been medication errors in the past. The manager has been trying to address this and has implemented a new system for medication recording. Despite this, there are still some shortfalls. There are no thermometers for the medication refrigerator or medication cabinet, and one prescribed medication was not recorded on the correct form, with the potential that the administration of this may then be missed.

One child and one young person have left the home and two children have moved into the home in the last few months. The young person who left the home did so in a very planned way and his social worker was very complimentary about the efforts that the manager and staff made to make this a successful transition. Sadly, the other move was not planned, but the child did make progress while he was at the home. The two children who moved into the home have done so following good planning, and in one case, visiting the home in advance. However, although the practice both for transitions in and out of the home has been good, there is very little written evidence in the children's case files to support this. Consequently, they will not have a coherent record of their journey, should they choose to access their case files in the future.

Children are not engaging in risk-taking behaviour such as going missing or misusing drugs or alcohol. Incidents of challenging behaviour are decreasing as children respond to the nurturing, consistent care and the involvement of the home's therapist. The recording of restraint has improved, although there are times when the language used could be more specific. The manager is addressing this. Incidents are monitored and evaluated so that the staff can learn and amend future responses if necessary. Complaints are taken seriously, and the child receives a written response to any issues raised. Allegations against staff have been responded to appropriately and there is good liaison with the designated officer for the local authority.

Partnership working is a strength and contributes to the good outcomes. One social worker said: 'The communication is the best I have ever had', and a stakeholder said that communication 'is absolutely brilliant'. The consistency that ensues from all the professionals working together is vital for the children to make good progress. A social worker said that the staff are quick to implement any suggestions and address issues through direct work sessions.

A number of requirements and recommendations were set at the last inspection. These have been addressed satisfactorily. Staff are all in the process of completing their qualification. They are all trained in first aid, and they are all now receiving regular supervision. This has had an impact on their overall confidence and competence to



deliver good care and support. Recording has improved, although the new system has some deficits that the manager is attempting to address.
