Summary of key findings for parents

This provision does not meet requirements

- The childminder understands how to support young children's development. She knows how to monitor children's progress and how to move them forward. The childminder discusses her strategies for involving parents in children's learning and for ensuring continuity in care. She has experience of working with other professionals to support children with special educational needs.
- The childminder knows how to support children in their personal development. She talks about how she promotes independence and supports children to develop social skills. The childminder discusses the ways in which she provides for children's health and well-being, for example, by providing frequent exercise and nutritious meals.
- The childminder comprehends how to safeguard children. She knows how to recognise if a child's welfare is at risk and the action to take in the event of a concern. She demonstrates an awareness of the risk assessments she has in place to ensure children are safe in her care.
- The childminder continues to develop her professional knowledge and skills to ensure her understanding of her role remains current.
- The childminder has not renewed her public liability insurance since she has had no children on roll and is not currently insured.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
