Information about this children's home

The home provides care and accommodation for up to four children who present with challenging complex behaviours. The manager was registered with Ofsted in November 2018.

This inspection

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged requires improvement to be good at the last full inspection. At the interim inspection, Ofsted judges that it has sustained effectiveness.

At the last inspection, eight requirements and five recommendations were set. The home's new manager has addressed five of these requirements and all five of the recommendations. Three of the requirements have been reset and three further requirements have been set at this inspection.

Although currently calm, the home has been through an unsettled period. There has been a high number of incidents and physical interventions. Several of these incidents have resulted in staff sustaining a significant number of injuries, some of which required hospital attention. On occasions, children also sustained injuries during the interventions. These incidents are recorded. However, the manager has not robustly reviewed each incident record to assess the effectiveness of the strategies implemented. Debriefings with the staff are not clearly recorded, and there is no formal review or action plan

following the incidents. This does not demonstrate effective management oversight.

Several of the incidents since the last inspection are considered by inspectors as significant events. For example, a child, while missing from the home, was located intoxicated, self-harming and requiring hospital treatment. No notification was made to Ofsted. Lack of notification to Ofsted of significant events prevents Ofsted from being able to monitor the home and the action taken to ensure children's safety.

The statement of purpose has been updated to reflect changes in practice. Recent amendments have resulted in updates to the staffing arrangements. However, this version of the document was not submitted to Ofsted as required by regulation.

The children have difficulties in engaging with education. Limited progress has been achieved in this area. One child received school work to undertake at the home, which was supported by the staff. However, other children have engaged in no meaningful educational activity. The requirement is restated.

The fire risk assessment was updated following the last inspection, but it has not been updated recently. The risk assessment states that the home has a no-smoking policy on the premises. However, children who smoke have been permitted to do so in the enclosed garden area. The risk assessment contains no information about a recent incident involving a child using a toaster to ignite a cigarette. Thus, there is a failure to record any actions required to reduce the risks identified.

The newly registered manager, along with a relatively new staff team, is in the process of making improvements to the home and practice. Records show that some positive relationships between staff and children have been established. However, the statement of purpose is not fully embedded into practice at this time.

The home has recently been refurbished to a high standard. The decor, furniture, pictures and accessories give a homely atmosphere for the children to enjoy. Each child now has a lockable cabinet in their bedroom. This enables the children to securely store their personal items. A new cordless phone has replaced the previously broken phone, so that the children can make calls in private if this is in line with their care plans.

The manager has ensured that each child has access to activities both in and outside of the home. The home now has a selection of DVDs and a games console for the children to use. Individual hobbies such as swimming and fishing have been supported and encouraged.

The children's individual behaviour management and risk assessment documents are now updated regularly. This means that staff have clear guidance on how to respond consistently to individuals' behaviour.

External monitoring of the home has improved. The independent person provides the manager with a monthly report that gives their opinion of the home's effectiveness of safeguarding the children.



Children's meetings are held regularly, and the manager also holds a monthly meeting with the children. The children's views are sought, and realistic wishes and requests are followed through. During these meetings, the menus for the week are planned. Children are encouraged to eat healthy meals, and the menus now reflect children's individual dietary likes and requirements.

There have been significant changes to the staffing since the last inspection. The present team is committed to improving the service. The new manager has made improvements to safe recruitment practice at the home. Previously, the manager interviewed staff independently. Now, the manager and the responsible individual conduct all interviews together.

The home accepts emergency admissions. The manager aims to ensure that he is present at each child's admission. However, should a child arrive when the manager is not present, suitably skilled and experienced staff are available to admit a child.

Two of the children present at the last inspection have now moved on. Three children have moved in, and two of these children have recently left. One placement was ended by the provider. The other child returned to live with their family. Transitions, when possible, have been planned and supported well. There is currently only one child, who arrived very recently, in placement. This child said, 'I'm really glad to be here. Staff have made me feel so welcome.'

This inspection focused on the effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection.

Using the 'Social care common inspection framework', this inspection was carried out under the Care Standards Act 2000 to assess the effectiveness of the service, how it meets the core functions of the service as set out in legislation, and to consider how well it complies with the Children's Homes (England) Regulations 2015 and the 'Guide to the children's homes regulations including the quality standards'.
