Summary of key findings for parents

This provision is inadequate

- The provider has not taken sufficient action to raise standards and demonstrates a poor capacity to improve. Although some actions raised at previous inspections have been addressed, other weaknesses remain. In addition, there are now further areas of concern and the overall quality of the provision remains poor.
- Staffing arrangements are not effective. The provider does not ensure that there is always a suitably qualified manager or deputy present.
- The provider does not ensure that first-aid qualified staff are deployed effectively to be able to respond quickly in the event of any medical emergency.
- The key-person system is not effective. Children do not benefit from consistent support to meet their individual care and learning needs.
- Staff do not fully embed partnerships with parents. They do not develop a good twoway flow of information to help them meet individual children's care and learning needs.
- Staff do not accurately identify or intervene to support children who are making less than expected progress. Staff do not engage with other professionals in a timely manner and gaps or delays in children's learning are ignored.
- The manager does not monitor children's learning or staff's teaching practice closely enough. Staff do not receive enough support to help them to provide good-quality learning experiences for children.
- Teaching is weak. Observation and assessment are ineffective. Planning of activities to match the interests and needs of the children is not focused and purposeful. These weaknesses hinder children's progress.

- The inspector held a meeting with the owner and nursery manager. She looked at relevant documentation and evidence of the suitability of staff working in the nursery.

Inspection findings

Effectiveness of leadership and management is inadequate

Safeguarding is not effective. There is not always a named deputy available to take charge in the manager's absence. The manager does not ensure that staff with paediatric first-aid qualifications are deployed effectively because she is unsure who holds the relevant qualifications. This means children's welfare is not assured. The manager fails to identify or address gaps or delays in children's learning. She does not always seek advice from other professionals when appropriate. There is no effective plan, coordinated approach or targeted intervention in place to support the learning and development of all children who are making less than expected progress. Staff attend supervisory sessions, meetings and further training. However, these have not been effective in raising the quality of their practice. The provider and manager have completed some evaluation of the provision. In addition, the manager has received support from the local authority. She has identified areas of consistent weakness, particularly around inaccuracy in staff's assessments of children's progress. However, the overall quality of teaching is still not good enough, despite being raised as a weakness at the previous inspection. The provider has not acted swiftly enough to raise the overall quality of the provision. Some previous areas of concern have been addressed appropriately. Risk assessment processes are sound. Children play in a safe and secure environment.

Quality of teaching, learning and assessment is inadequate

The quality of teaching is variable. Although some observations and assessments of children's learning are in place, these are not always accurate. Staff working with children do not have a good enough understanding about what children already know and what they need to learn next. They do not plan experiences precisely enough to promote learning for all children, including those children who have significant delays in their development. Most staff simply supervise children and their interactions are not focused and purposeful. Staff do not consistently provide children with a stimulating and challenging learning environment. When activities do interest children they are not always organised effectively enough. For example, too many children crowd around an easel and get frustrated when they cannot reach the resources or participate fully. During outdoor play, staff mostly watch children as they play on tricycles and scooters. They do little to engage or stimulate children to play and learn. Children who do not have a wheeled toy wander around aimlessly. These weaknesses limit the amount of progress children make in their learning and development.

Personal development, behaviour and welfare are inadequate

Children's welfare is not fully promoted due to significant weaknesses in safeguarding practice. The high turnover of staff and the frequent use of agency staff mean that children's emotional development is hindered. Children are not given enough opportunities to form a close relationship with a key person who is able to be responsive to their care and learning needs. Partnerships with parents are not strong. Staff have not developed a successful two-way flow of sharing information. Children do not benefit from good continuity between the setting and home. Nevertheless, children appear generally content and settled at nursery. Staff support children to follow the boundaries

of the setting. Children behave well.

Outcomes for children are inadequate

Children of all ages, including those who are in receipt of additional funding, are not prepared well for the next stage in their learning. They do not develop confidence in the key skills they need to be ready for their eventual move on to school.
