Information about this children's home

The home provides care and accommodation for adolescent males with histories of trauma and disrupted attachments and of harmful sexual behaviour. It is registered to provide care and accommodation for up to four children.

The manager has been registered with Ofsted since July 2018.

This inspection

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged to require improvement to be good at the last full inspection. At the interim inspection, Ofsted judges that it has improved effectiveness.

The home now has a permanent, registered manager, the absence of which was the reason for the requires improvement to be good judgement at the full inspection. She is knowledgeable about the children and their needs and is keen to continually improve the quality of care provided to them. She acknowledges that the physical environment, although improved, requires further redecoration and refurbishment. Therefore, this recommendation remains.

Since the last inspection, two children have moved into the home in a meticulously planned manner. One child has moved on to supported living. Although this was recognised as a rushed move, it was due to the need for him to be in his new home area



to start college and was a positive move for him.

Children make steady progress living in the home. They learn how to manage social situations and how to be independent, through a staged programme of therapeutic interventions. The children can all reflect on the progress they have made. A social worker was particularly positive regarding the progress made by the child he has placed, and said, 'He is in the right home, which is a relaxed environment', and that he is now attending school 100% after not attending for an extended period. Children commented positively on the home and staff, while busily getting ready for a Christmas party that evening. Memory books and 'positive' books are well thought through and allow children to reflect on fun days out and for staff to comment on something funny or when the children have been helpful around the house.

Children are effectively safeguarded in the home. Staff are aware of processes to follow should they be worried about a child's safety or welfare. Joint working with the organisation's therapy team means that children are supported when they are struggling emotionally, including after recent incidents of self-injurious behaviour for some. Children have not been missing since the last inspection, although all have clear plans to follow should they be. The local police have good links with the home, supporting children to have a positive relationship with them, despite the children's previous experiences of offending.

Since the last inspection, the registered manager has worked to ensure that all requirements and recommendations set at the last inspection have been met. However, more work is needed to refurbish the home. The home's risk assessment has been updated to reflect staffing numbers required to support those currently living in the home with their individually assessed needs. Staff have had training in the organisation's core values and approach to care in addition to mandatory training. Medication arrangements are now more robust and include a prompt on who requires medication at which time. The registered manager now has regular supervisions with her line manager and with the organisation's therapy team. Children's key-work sessions have significantly improved and include a review of topics covered and how to make them a more engaging experience for children. The manager is continuing to develop this area.

This inspection focused on the effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection.
