# What does the children's home need to do to improve? Statutory requirements

This section sets out the actions that the registered person(s) must take to meet the Care Standards Act 2000, Children's Homes (England) Regulations 2015 and the 'Guide to the children's homes regulations including the quality standards'. Requirement	Due date
20: Restraint and deprivation of liberty	20/01/2019
Restraint in relation to a child is only permitted for the purpose of preventing injury to any person (including the child); serious damage to the property of any person (including the child); or a child who is accommodated in a secure children's home from absconding from the home. Restraint in relation to a child must be necessary and proportionate. (Regulation 20(1)(2))	
In particular, ensure that children and young people are not prevented from having freedom of movement, for example by using zips to secure 'safe-space' beds.	

### Recommendations

■ Ensure that staff are familiar with the home's policies on record keeping and understand the importance of careful, objective, and clear recording. Staff should record information on individual children in a non-stigmatising way that distinguishes between fact, opinion and third-party information. Information about the child must always be recorded in a way that will be helpful to the child ('Guide to the children's homes regulations including the quality standards', page 61, paragraph 14.4). In particular, ensure that the recording of incidents is kept under review and that the document used for this purpose is child focused and facilitates management monitoring.

# **Inspection judgements**

## Overall experiences and progress of children and young people: good

This children's home has been rated good at each full inspection since it was registered in 2016. The single regulatory shortfall found during this inspection has had a limited impact on the young person concerned, so it does not affect the overall judgement.

Staff provide an exceptionally responsive, child-focused service which meets individual



children and young people's needs. Warm, nurturing relationships with the staff contribute to the children and young people's enjoyment of their short breaks. One parent said that her child asks every morning whether he is going to visit the home that day.

The home provides an exceptionally attractive, homely environment for each child and young person, with their rooms individualised according to their needs. Since the last inspection, the home has been further enhanced by a new kitchen and the provision of additional play equipment for the garden.

Children and young people are kept safe from harm. Their complex healthcare needs are very well met. Medicines are managed and recorded safely.

Consultation with children and young people, parents and professionals takes place regularly to ensure that their views are represented. The staff use a variety of visual and verbal communication systems to enable the children and young people to express their views about every aspect of their care. The home has received extremely positive feedback from all those surveyed.

The children and young people are encouraged to take part in a wide range of activities, both inside and outside the home. Photos taken during activities are shared with their parents and saved for them in a memory book. This enables the children and young people to have lasting records of their visits to the home.

The home has made a significant contribution to the children and young people's progress. One young person can now, with support from the staff, plan, shop for and cook a meal for everyone. Others are making new friends and learning social and communication skills. Improving their independence skills helps the children and young people to enhance the quality of their lives.

# How well children and young people are helped and protected: requires improvement to be good

This outcome area requires improvement to be good because in one case, there was no Deprivation of Liberty Safeguards protocol in place to safeguard one young person's rights. A requirement has been made with regard to this. The registered manager took immediate action to resolve the matter and directed staff to cease the practice that involved deprivation of liberty.

Effective, regularly updated risk assessments, staff training in safeguarding, and productive relationships with other agencies help the home to keep the children and young people safe from harm. There have been no concerns with regard to the safeguarding of the children and young people.

Two new staff have been appointed since the last inspection. The recruitment process is rigorous and helps to reduce the risk of appointing unsuitable people.



Health and safety checks and fire safety checks are carried out at appropriate intervals. Each child and young person has a personal evacuation plan to assist the fire service and staff in the event of an emergency.

The children and young people receive high-quality care to support them when they become distressed or frustrated. As a result, there have been only five restraints since the last inspection. These have been brief interventions which were appropriate to the situations. Children, young people and staff receive good-quality support following any restraint. The staff and manager reflect on each incident afterwards, to help them to apply any learning to future behaviour management.

# The effectiveness of leaders and managers: good

This is a well-managed home. The experienced, skilled registered manager is qualified at level 4 in leadership and management, and is currently undertaking the level 5 award. She and her staff are passionate about providing a highly professional, responsive service for children and their families.

The staff feel very well supported through regular supervision and relevant training. They are highly motivated and said that they love coming to work. As a result, staff turnover is low. Any vacant shifts are filled within the team, to help ensure continuity of care for the children and young people.

The registered manager has a very good understanding of the children and young people's progress. She monitors all aspects of the service very well. The manager makes effective use of the regular external monitoring from the independent visitor to drive further improvement. She is well supported by the company's senior leaders, some of whom visited during the inspection.

The responsible individual for this home has recently resigned. Up until recently, she was meeting regularly with the registered manager to provide an overview of the business-related aspects of the service.

The manager and staff work exceptionally well with other agencies to support the children and young people effectively. Social workers and parents are extremely positive about the quality of care their children receive. They said that the home provides an excellent, highly supportive short-break service.

At the previous inspection, there was an isolated example of a medicine record which did not include the dosage. This was remedied immediately. At this inspection, medicine records were found to be well maintained.

The children and young people's records are of good quality and provide sufficient information. However, the incident reporting form has changed since the last inspection. This document is not of the same high standard as the home's other records. For



example, it does not include individual responses to children and young people or facilitate efficient management monitoring. A recommendation has been made with regard to this.

# Information about this inspection

Inspectors have looked closely at the experiences and progress of children and young people. Inspectors considered the quality of work and the differences made to the lives of children and young people. They watched how professional staff work with children and young people and each other and discussed the effectiveness of help and care provided. Wherever possible, they talked to children and young people and their families. In addition, the inspectors have tried to understand what the children's home knows about how well it is performing, how well it is doing and what difference it is making for the children and young people whom it is trying to help, protect and look after.

Using the 'Social care common inspection framework', this inspection was carried out under the Care Standards Act 2000 to assess the effectiveness of the service, how it meets the core functions of the service as set out in legislation, and to consider how well it complies with the Children's Homes (England) Regulations 2015 and the 'Guide to the children's homes regulations including the quality standards'.
