Summary of key findings for parents

This provision does not meet requirements

- The childminder has not kept her paediatric first-aid training up to date as required. This means that she may not have the most recent knowledge in an emergency situation.
- The childminder is aware of the learning and development requirements. She knows how to observe and assess children's learning in order to plan activities that provide children with suitable challenge and encourage their ongoing development.
- The childminder demonstrates through discussion that she has a sound understanding of how to safeguard children in her care. She is confident to take action to protect children's welfare in the event of a child protection concern.
- The childminder acknowledges the importance of working closely with parents and other professionals to support continuity of care and learning.
- The childminder recognises the value of helping children to follow healthy hygiene routines and how to support them to develop their independence skills. She understands how this helps them to be ready for starting school.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What the setting needs to do to improve further
