#### Information about this children's home

This children's home is operated by a private company. The home is registered to provide care for up to three children who have difficulty with managing their emotions and behaviour.

The registered manager left in December 2017. Another manager was appointed but left before they were registered. Subsequently, another manager was appointed but left before registering with Ofsted. A new manager has been in post since 28 January 2019. They are not yet registered with Ofsted.

### This inspection

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged requires improvement to be good at the last full inspection.

At the interim inspection, Ofsted judges that it has sustained effectiveness.

This home has been without a registered manager for 57 weeks. Changes in leadership mean that inconsistency in staff practice is not addressed quickly enough. This has resulted in a lack of continuity in children's care and an increase in allegations and incidents. One child moved on from the service because staff could no longer keep the child safe.

Permanent staff do their best to ensure that children receive good help and support. The

permanent staff are good at encouraging the children to talk about their experiences and helping the children to learn about some of the skills necessary for becoming independent. The permanent staff do a good job of sharing information with other agencies after an incident has occurred. Placing local authority social workers are kept up to date with what happens at the home. However, consistent and effective managerial oversight is lacking.

The home accepts emergency admissions. The children have complex social histories and directly challenge the staff. Sometimes, staff are unable to successfully de-escalate the children's behaviour. As challenges have arisen, the provider has acted responsibly by ensuring that additional staff work on shift. This arrangement has some benefits some of the time because, for example, there are often enough adults to ensure that children receive individual attention. However, inconsistent arrangements for the vetting, induction and support of agency staff result in an escalation of incidents. This means that not every person working at the home has sufficient experience, qualifications and skills to meet the needs of each child.

Written risk assessments draw attention to each child's vulnerabilities and identify when known behaviour poses a risk. Risk assessments provide strategies to reduce the likelihood of children causing harm to themselves. However, the progress that children make over the time of their placement is significantly jeopardised because not all staff follow the guidance in the risk assessments. This increases the likelihood of vulnerable children, and staff, coming to significant harm.

The provider has met some of the requirements that were made at the last full inspection. Communication with the designated officer has improved, and some of the staff appraisals have been undertaken. However, the responsible individual was unable to evidence that every eligible member of staff has received an appraisal.

The newly appointed responsible individual was present during this inspection and provided information about the current plans to improve the service. These plans include meeting the quality standards by submitting the overdue report of the review of the quality of care and the updated statement of purpose. Currently, up-to-date information about the service delivered and feedback about the quality of care from children, placing authorities, parents and staff have not been submitted to Ofsted.

On the day prior to the inspection, one of the deputy managers was appointed as the home's manager. This arrangement has the potential to offer children and staff stability. Ofsted awaits an application for registration from the new manager.

In particular, provide supervision to agency staff who work at the home regularly.	



#### **Recommendations**

- The information set out in the Statement of Purpose is an essential part of the process of agreement between the registered person and placing authority that a placement at the home is the right one for that child, and that the home will be able to respond effectively to the child's assessed needs. ('Guide to the children's homes regulations including the quality standards', page 14, paragraph 3.6)
- All staff must have their performance and fitness to carry out their role formally appraised at least once annually. This appraisal should take into account, when reasonable and practical, the views of other professionals who have worked with the staff member over the year and children in the home's care. ('Guide to the children's homes regulations including the quality standards', page 61, paragraph 13.5)
- Regulation 45 sets out requirements for the registered person to have a system in place which allows them to monitor the matters set out in the regulation at least once every six months; also see regulation 13 (2)(h) (the leadership and management standard). The registered person should undertake a review that focuses on the quality of the care provided by the home, the experiences of the children living there and the impact that the care is having on outcomes and improvements for the children. Reviews should be underpinned by the Quality Standards as described in regulation 5 to 14. ('Guide to the children's homes regulations including the quality standards', page 64, paragraph 15.2)

### Information about this inspection

Inspectors have looked closely at the experiences and progress of children and young people. Inspectors considered the quality of work and the difference made to the lives of children and young people. They watched how professional staff work with children and young people and each other and discussed the effectiveness of help and care provided. Wherever possible, they talked to children and young people and their families. In addition, the inspectors have tried to understand what the children's home knows about how well it is performing, how well it is doing and what difference it is making for the children and young people whom it is trying to help, protect and look after.

This inspection focused on the effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection.

Using the 'Social care common inspection framework', this inspection was carried out under the Care Standards Act 2000 to assess the effectiveness of the service, how it meets the core functions of the service as set out in legislation, and to consider how well it complies with the Children's Homes (England) Regulations 2015 and the 'Guide to the children's homes regulations including the quality standards'.
