Summary of key findings for parents

This provision meets requirements

- The childminder has a secure understanding of her duty to protect children. She recognises the possible signs that could indicate a child is at risk of harm and understands the procedures to follow if she had a concern about children's welfare.
- The childminder recognises the importance of professional development in supporting the quality of her practice, teaching and of children's learning. She ensures she keeps required training, such as first aid, up to date.
- The childminder knows how to seek the views of parents, children and others to help evaluate the quality of her service.
- The childminder demonstrates a clear understanding of the learning and development requirements for children. She knows how to observe and assess children's progress and how to plan for their next steps in learning.
- The childminder understands how to support children's positive behaviour to help them understand appropriate rules and to respect each other's differences.
- The childminder has a secure understanding of her role to promote children's good health and well-being and to keep them safe. She describes how she will meet children's individual needs and she is aware of the importance of providing them with a healthy diet. The childminder describes how children will have regular opportunities to be active.
- The childminder understands the importance of working with parents, external professionals and other early years providers, to promote continuity and progression in children's learning and development.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the childminder how she intends to deliver the educational programmes for children and her understanding of the learning and development requirements.
- The inspector reviewed the childminder's knowledge of the safeguarding and welfare requirements. She looked at documentation, including the childminder's training certificates, and reviewed evidence of the suitability of the members of the household.
- The inspector had a tour of the areas of the premises used by children and discussed the equipment and toys available.
- The inspector discussed with the childminder how she intends to evaluate the effectiveness of the service she provides to children.
- The inspector discussed with the childminder the importance of including parents, other providers and professional agencies in children's learning and development.
