This provision meets requirements

- The childminder has a suitable understanding of how to support children's learning. She knows how to monitor children's progress and plan activities to help support children's individual needs and interests.
- The childminder understands the importance of continually evaluating her childcare service to identify areas to improve. She accesses training to keep her skills up to date.
- The childminder demonstrates well how she will support children's healthy lifestyles. For example, she says that the children will have plenty of exercise and fresh air, and that she will promote healthy eating and follow good hygiene practices.
- The childminder has a positive attitude towards promoting diversity. For example, she will provide freshly prepared and healthy cultural meals and will offer a variety of activities and experiences to reflect children's cultural backgrounds.
- The childminder has a good understanding of the safety and welfare requirements. She understands safeguarding and wider child protection concerns. She demonstrates a secure understanding of the local reporting procedures if she has a concern about a child's welfare.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
