### Summary of key findings for parents

#### This provision meets requirements

- The childminder is familiar with child protection issues and the procedures to report any concerns, including allegations, to the relevant authorities.
- The childminder knows how to access professional development opportunities and how to seek support from the local authority early years coordinator to help enhance her knowledge and skills.
- The childminder recognises the benefits of working in partnerships with parents, to share information about children's learning and to plan what they should do next to extend their development.
- The childminder knows how to evaluate the provision to continually identify her strengths and areas for development.
- The childminder understands how to support children to develop their personal, social and emotional well-being. She recognises the importance of making children aware of behaviours that are acceptable and unacceptable, to teach them right from wrong.
- The childminder has knowledge of how to observe and assess children's learning. She describes a range of opportunities to help them make good progress, in relation to their starting points.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

#### **Inspection activities**

- The inspector discussed with the childminder how she intends to provide activities and experiences that support children's learning.
- The inspector looked at the childminder's policies and documents that she intends to use when caring for children.
- The inspector discussed with the childminder her processes for self-evaluation and her improvement plan.
- The inspector viewed resources and had a tour of the areas of the childminder's home that she intends to use for childminding.

The childminder registered in 2011. She lives in Edmonton, within the London Borough of Enfield. The childminder holds an early year qualification at level 3. The childminder operates Monday to Friday from 8am to 6pm, throughout most of the year.
