# **Summary of key findings for parents**

### This provision does not meet requirements

- The childminder has failed to address fully all actions raised at the previous inspection. The childminder's understanding and use of English is insufficient to ensure the well-being of children in her care. The childminder has not informed Ofsted about changes to household members so that appropriate suitability checks can be completed. She has not notified Ofsted of changes to her working hours. She does not have appropriate car insurance in place for when she transports the children she cares for. These are also breaches of the Childcare Register.
- The childminder does not have a sufficient understanding of most aspects of safeguarding and she fails to protect children appropriately. She demonstrates that she is not fully aware of signs and symptoms of possible abuse. These weaknesses are also a breach of the Childcare Register.
- The childminder's knowledge and understanding of how to support children's learning and development are extremely weak. She does not understand the purpose of observation and assessment. She does not know how to support children to make progress and prepare them for school.
- Since the last inspection, the childminder has shown some willingness to improve her practice. For example, she has attended training to develop her skills and to help her understand the early years curriculum. However, the childminder acknowledges that her use and understanding of English are weak. As a result, these weaknesses limit her understanding of her responsibility to meet the early years foundation stage requirements.
- The childminder understands how to promote children's good health, including by providing drinking water and snacks such as fresh fruit.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
