Summary of key findings for parents

This provision is inadequate

- The provider does not safeguard children. She has failed to make sure that all staff are alert to potential concerns about children. The provider does not have robust recruitment and vetting procedures in place. The provider does not make sure that staff taking children on outings have the required first-aid qualification.
- The provider does not implement effective systems to monitor the performance of staff and drive improvements to the quality of practice.
- The provider does not gather important information from parents about their children before they start at the setting.
- Staff do not manage children's behaviour appropriately. As a result, children do not always know what is expected of them.
- The provider does not make sure that children are cared for by staff who know them best and help them to form secure relationships with others. Children often play alone rather than joining in with others.
- Staff do not complete regular or accurate assessments of children's learning and development. They do not plan activities that support children's current stage of development or extend their learning experiences. Therefore, children are not well prepared for their next stage of learning.
- Staff do not support parents with children's learning at home.

It has the following strengths

Staff support children's understanding of how to stay safe. They remind children to sit properly on chairs so they do not fall.

What the setting needs to do to improve further

The provision is inadequate and Ofsted intends to take enforcement action:

Inspection activities

- The inspectors looked at records of children's development, evidence of the suitability and qualifications of staff working in the nursery and a range of other documentation.
- The inspectors talked to staff about how they support children's individual learning and how they keep children safe.
- The inspectors took account of the views of the parents spoken to on the day of the inspection.
- The inspectors carried out a joint observation with the provider to look at the quality of teaching and the impact on children's learning.
- The inspectors held a meeting with the provider.

Inspection findings

Effectiveness of leadership and management is inadequate

Although the provider has a higher level childcare qualification, she does not demonstrate the knowledge and skills to meet the requirements of the early years foundation stage. She has failed to take the required action to address some of the breaches of requirements identified at a recent visit from Ofsted. Furthermore, there are additional breaches of requirements identified at this inspection. Safeguarding is not effective. The provider has not made sure that staff know how to respond when they have child protection concerns. As a result, children are not appropriately safeguarded. The provider does not have robust systems for vetting and recruiting new staff. New staff start work before the provider is assured of their suitability to work with children. This places children at potential risk. The provider does not have an accurate view of the quality of teaching. This means that any monitoring of staff practice is ineffective and does not help children to have the best possible learning experiences. The provider does not challenged when their methods are inappropriate. The provider does not gather the required information about children before she begins caring for them.

Quality of teaching, learning and assessment is inadequate

Despite the majority of staff having a childcare qualification, teaching is ineffective. Staff at the nursery do not make regular and accurate assessments of children's stages of development. Staff do not identify the most appropriate support to help children move forward and prepare them for their next stage in learning. Staff do not help children to build on the knowledge they already have. Staff ask children questions that they already know the answer to. As a result, children do not learn anything new. Staff encourage and praise younger children as they participate in a painting activity, but do not teach them any new skills or support their progress. Staff do not give children enough time to contribute their views and thoughts during conversations. This does not support children's learning, for example, to develop their communication skills. Staff do not share information with parents consistently. They do not talk to parents about what children are learning at home. Staff do not inform parents of what they are helping children to learn next in order to ensure there is consistent support.

Personal development, behaviour and welfare are inadequate

Staff do not have an appropriate knowledge of children in their care. They fail to recognise children's interests in certain activities and, as a result, discourage children from participating fully. Staff do not set appropriate boundaries for children's behaviour or help them to understand what is expected of them, for example during lunchtimes. At times, staff respond negatively to children and do not follow the setting's agreed strategies for managing children's behaviour. Parents compliment the variety of healthy meals that staff provide for children.

Outcomes for children are inadequate

Staff are not clear on the progress some children are making. Furthermore, the poor quality of teaching provided means that children do not demonstrate the skills, knowledge and understanding appropriate for their age. This applies to younger and

older children who attend. Children show independence and confidence in the nursery. However, they are often quiet and do not attempt to manage their own personal care.

Alison's Childcare And Early Education (ACE) Ltd registered in 2016 and is located Swadlincote, Derbyshire. The nursery employs 10 members of childcare staff. Of these, nine hold appropriate early years qualification at level 2 or 3, and the manager holds a foundation degree in early years studies. The nursery opens from Monday to Friday, all year round, except for a week between Christmas and New Year, and bank holidays. Sessions are from 7am until 6.30pm. The nursery provides funded early education for three- and four-year-old children.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
