Summary of key findings for parents

This provision meets requirements

- The provider has an up-to-date knowledge of child protection issues, including what might indicate that a child is at risk of extreme views and behaviours. She is confident in reporting any concerns to relevant agencies to protect children's welfare.
- The provider supports her and staff's professional development to secure their knowledge and skills. She is aware of the need to check staff's suitability and risk assess the premises to help keep children safe.
- The provider has a range of suitable toys and resources to ensure young children are occupied at the club. She understands how they will use observations to plan age-appropriate activities.
- The provider recognises the importance of working with parents and teachers at the school that children attend to complement their learning. She knows how to seek their views to help evaluate the quality of the provision.
- The provider is aware of how to assist young children's emotional and physical well-being. For example, she intends to encourage positive behaviour in children and staff.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the provider how she plans to meet the requirements of the early years foundation stage.
- The inspector looked at the equipment and toys that are available for the use of young children.
- The inspector sampled documentation, including staff qualifications, policy and procedures. She toured the premises and discussed the risk assessment checks with the provider.
- The inspector spoke with the provider about her understanding of safeguarding, child protection and the self-evaluation process.

Munchies @3rd Hampton registered in 2016. It is located in the London Borough of Richmond-upon-Thames. The club operates before and after school sessions from, 7.30am until 9am and 3pm until 6pm, Monday to Friday during school term times only. There are nine staff members, including the provider; of these three hold childcare qualification at level 3 and two at level 2.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
