Information about this children's home

This home is operated by a private company. It is registered to provide care and accommodation for young people who have learning disabilities and/or who exhibit complex behaviours because of their childhood experiences. The home provides care for up to three young people.

The registered manager has been in post since the home opened in October 2017. He holds a level 5 qualification in leadership and management.

This inspection

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged requires improvement to be good at the last full inspection. At the interim inspection, Ofsted judges that it has improved effectiveness.

At the last inspection in August 2018, seven requirements and five recommendations were raised. At this inspection, inspectors found that five requirements and four recommendations have been met. For the remaining two requirements, work is in progress.

Since the full inspection in August 2018, one young person has left the home and two young people remain in placement. Young people told the inspector that the home is a much more settled place to live and somewhere that they now feel comfortable. One young person told the inspector that the young people do argue at times but more like

'brother and sister'.

The young people who live in the home are making good progress. Both young people are attending school and are positive about their learning. One young person has achieved pupil of the week. This is a real achievement.

Young people show improved health. For example, increased staff attention to healthy eating has helped one young person to lose weight.

Staff provide young people with opportunities to take part in activities that interest them. For example, one young person has joined the St John Ambulance. Another young person has continued to develop his interest in boxing and has recently spoken on local radio about the positive impact that boxing has had on his life. These positive opportunities encourage young people's self-esteem and support them to develop links in the local community.

Young people's risk-taking behaviours have reduced and there are fewer incidents in the home which require staff to physically intervene. The registered manager has carried out a review of young people's risk assessments. However, in doing so, the registered manager has removed some historical risks that do remain relevant. This leaves staff without all the necessary information that they require to enable them to safeguard the young people.

The registered manager has implemented a plan to support young people to develop their independence skills. This is very new and therefore the impact is not yet known.

The registered manager has taken steps to improve the safety of the home environment. Previous oversights regarding fire safety have been addressed. The system for monitoring and dispensing of medicines within the home has been improved and staff have received training in this area. However, previously identified failings in food hygiene remain and this ongoing poor practice places young people's health at risk.

There is still a heavy reliance on support from staff from other homes. As a result, 42 different members of staff have worked at the home since the full inspection in August 2018. This lack of consistency impacts the ability of the manager to further improve the service. Despite this continued inconsistency, young people are developing relationships with some staff and told the inspector that they would talk to staff members if they were concerned about anything.

The registered manager has ensured that all staff who work at the home have attended training in response to the issues raised at the full inspection. For example, staff have attended training to refresh their knowledge of physical intervention and de-escalation. This ensures that staff have the skills and knowledge required to care for the young people who live in the home.

The registered manager was unable to locate staff supervision records during this



inspection. As a result, it is not possible to identify what, if any, action has been taken to address the shortfalls identified at the full inspection.

At this inspection, one new requirement has been raised regarding standards of accommodation. The home offers a large, bright space for young people and there are recent improvements in furnishings. However, this is not yet completed in all areas of the home. For example, one young person's bedroom does not have sufficient furniture for him to store his belongings and he does not have enough hangers for his clothes. This does not support him in valuing and respecting his possessions and his environment.

One new recommendation has been raised. Staff do not always ensure that records offer sufficient detail to provide clear oversight of incidents.

Recommendations

- A record of supervision should be kept for staff, including the manager. The record should provide evidence that supervision is being delivered in line with regulation. ('Guide to the children's homes regulations including the quality standards', page 61, paragraph 13.3)
- Staff should be familiar with the home's policies on record-keeping and understand the importance of careful, objective and clear recording. Staff should record information on individual children in a non-stigmatising way that distinguishes between fact, opinion and third-party information. Information about the child must always be recorded in a way that will be helpful to the child. ('Guide to the children's homes regulations including the quality standards', page 62, paragraph 14.4)



Information about this inspection

Inspectors have looked closely at the experiences and progress of children and young people. Inspectors considered the quality of work and the differences made to the lives of children and young people. They watched how professional staff work with children and young people and each other and discussed the effectiveness of help and care provided. Wherever possible, they talked to children and young people and their families. In addition, the inspectors have tried to understand what the children's home knows about how well it is performing, how well it is doing and what difference it is making for the children and young people whom it is trying to help, protect and look after.

This inspection focused on the effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection.

Using the 'Social care common inspection framework', this inspection was carried out under the Care Standards Act 2000 to assess the effectiveness of the service, how it meets the core functions of the service as set out in legislation, and to consider how well it complies with the Children's Homes (England) Regulations 2015 and the 'Guide to the children's homes regulations including the quality standards'.
