Summary of key findings for parents

This provision is outstanding

- The conscientious and experienced childminder is deeply reflective of her own training needs. She implements high-quality methods that help to continually monitor and evaluate the quality of her provision. For instance, she keeps meticulous notes that reflect on her excellent practice and on the impact of professional training. The childminder records and reflects on how well children have engaged and responded to her questions. This helps to ensure that she tailors the curriculum to the individual needs of children exceptionally well.
- Parents give praise for the outstanding quality of care and education their children receive. The childminder works collaboratively with parents to ensure children's development is fully supported at home. As a result, children benefit from a wonderfully consistent approach. Parents have every confidence in the childminder's ability and value her as an extended family member.
- The childminder sensitively and skilfully reinforces children's positive behaviour and models high standards. For example, she talks to children about how to stay safe when playing with water beads.
- The childminder vigilantly risk assesses the environment to keep children safe without limiting their experiences.
- Children are motivated to learn and eager to share experiences with adults. For example, they delight in having animated discussions with the childminder as they talk about their favourite activities. They excitedly describe taking walks to feed the ducks and trips to the library to research the animals that they have found on their journey. As a result, children are exceptionally well prepared for the next stage in learning as their natural curiosity is fostered and supported.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

continue using the extremely creative and highly effective strategies for engaging parents in their children's learning at home to support children in readiness for their transition to school even further.

Inspection activities

- The inspector observed the quality of teaching during activities and assessed the impact this had on children's learning.
- The inspector spoke to children during the inspection and took into account the views of parents through reading the written feedback provided.
- The inspector held a number of discussions with the childminder and looked at a selection of relevant documentation.
- The inspector and the childminder jointly observed and evaluated the effectiveness of an activity together.

Inspection findings

Effectiveness of leadership and management is outstanding

Safeguarding is effective. The childminder prioritises children's safety and well-being so that these are at the very heart of her practice. For example, she implements rigorous risk assessments both in the home and on outings, taking exceptional precautions to plan for children's safety at all times. The childminder meticulously monitors outcomes for children. She ensures they all make excellent progress and quickly identifies any gaps in their development. Children benefit from exceptional levels of individual attention and interaction with the childminder. This helps them to develop mature language and vocabulary. The childminder offers an extensive range of resources and information for parents to support children's learning at home. She plans to provide more guidance for parents as children prepare for the transition to school.

Quality of teaching, learning and assessment is outstanding

Children's individual needs are supported exceptionally well. For example, exciting sensory experiences, such as water beads and foam, encourage children to explore different textures. As a result, they become increasingly confident and engage in new experiences enthusiastically. The childminder expertly introduces mathematical language. She successfully extends children's vocabulary and reinforces their own ideas, responding to children's mature questions about shape and quantity. The childminder supports children to develop excellent focus and concentration. For example, they use small-muscle control extremely confidently as they manipulate materials using a range of interesting utensils. The childminder uses her expert knowledge to provide challenge for children. For example, she revisits targeted activities to reinforce what children already know and offers greater challenge, for example increasing the range of coloured beads. This helps to ensure assessments are sharply focused.

Personal development, behaviour and welfare are outstanding

The childminder maintains exceptionally high standards of care and hygiene. She teaches children to understand the importance of being healthy and provides them with an extensive range of opportunities to be physically active. For example, children have access to an exceptional range of toys and resources both indoors and outside, and they enjoy wonderful outings in the local community. This helps to deeply enrich children's physical development and social skills. Children are exceptionally well behaved and flourish as they engage in warm, affectionate discussions with the childminder. For example, photographs of children hang on the walls and prompt conversations about family members. This helps children to feel settled and secure in the nurturing homefrom-home environment.

Outcomes for children are outstanding

The childminder's commitment and dedication to families help to provide children with an exceptionally secure start in life. As a result of the high-quality care provided, children feel valued, listened to and respected. This helps them become confident and motivated learners. They are happy to take risks and try out their own ideas when exploring creative activities. Children flourish in this extremely calm and supportive environment. As a result, they are exceptionally well prepared for future learning.
