Monitoring visit Inspected under the social care common inspection framework

Information about this children's home

This home is operated by the local authority. It provides a residential service for seven children and a short-break service for up to five children. All the children have moderate to severe learning disabilities.

Inspection date: 7 February 2019

This monitoring visit

This monitoring visit took place in response to an anonymous complaint about the service. The complainant gave several examples of poor practice, including serious medication errors. The complainant also stated that there are often not enough staff on duty to provide safe care to residents or children receiving short breaks.

At the last inspection, the home was required to ensure that sufficient staff are available to provide good-quality care to each child. Although managers are actively recruiting new staff, the service continues to operate with staff vacancies and a high level of sickness absence.

Over the last month, the number of staff on duty has fallen below the expected level on approximately half of all shifts. This increases the risk of mistakes such as errors in the administration of medication. Staff shortages also affect the quality of care and have an impact on the capacity of staff to spend one-to-one time with children. The short-breaks service has been particularly affected, with seven planned breaks being cancelled in the last month.

The interim manager and assistant managers have covered staff vacancies by regularly placing themselves on the rota. Managers have stepped in at short notice to cover last-minute notifications of absence. This has eased pressure on shift leaders but has had an effect on the quality of essential management tasks.

At the last inspection, weaknesses in the service's risk assessment and risk



management systems were identified. These shortfalls continue. For example, children have access to a kitchen in the residential area, but staff and managers are not clear about whether children must be supervised at all times when using the kitchen. This inconsistent approach has the potential to confuse children. Also, children might be allowed to take risks that have not been subject to rigorous assessment.

There has also been a lack of clarity over the decision to replace a small number of bedroom light switches with switches that can only be operated by staff. Although well intentioned, it is not clear that the change is necessary or proportionate in every case, or that it has been agreed by managers, parents or social workers.

It was identified at the last inspection that there had not been a robust response to medication errors by managers. Unfortunately, there have been a small number of errors in administering medication in recent weeks. One error was potentially serious. A number of changes have now been made to improve practice. All staff are in the process of receiving more rigorous training that includes an assessment of competencies.

There continues to be a need for effective quality assurance of practice by managers. This includes rigorous review of incidents to identify any patterns or themes which may be linked to staff shortages or staff competencies. It also includes the need to evidence progress made by children from their starting points, and to evidence how the home is supporting them to reach their potential. The interim manager recognises this. She has plans to improve quality assurance. However, because managers have been covering for staff absence, progress has been slower than anticipated.

Despite the pressures placed on staff and managers by staffing shortages, the team remains committed to the service and committed to the care of the children. Interactions with children continue to be caring and nurturing. Staff have not allowed the staffing pressures to affect the way that they communicate with children.

The interim manager has liaised with appropriate services to ensure that staff returning to work are given the support that they need. Staff reported that managers are accessible and visible.

The requirements made at the last inspection are repeated. It is essential that an updated action plan is implemented.

Recommendations

- Children should be supported to express themselves as individuals and should be given an appropriate degree of freedom and choice in relation to day to day arrangements for their care. ('Guide to the children's homes regulations including the quality standards', page 17, paragraph 3.21) This is with specific reference to consulting with children regarding preference of gender to provide personal care, if this is required.
- For children's homes to be nurturing and supportive environments that meet the needs of their children they will in most cases be homely domestic environments. Homes should seek as far as possible to maintain a domestic rather than institutional impression. ('Guide to the children's homes regulations including the quality standards', page 15, paragraph 3.9)



This is with reference to reviewing the practice of use of walkie talkies by staff while caring for children.

Children must be consulted regularly on their views about the home's care, to inform and support continued improvement in the quality of care provided. Due consideration should be given to the child's cognitive ability in the development and implementation of any consultation processes. Children should be able to see the results of their views being listened to and acted upon. ('Guide to the children's homes regulations including the quality standards', page 22, paragraph 4.11)
