## This inspection

# The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged requires improvement to be good at the last full inspection. At the interim inspection, Ofsted judges that it has sustained effectiveness.

The home has continued to operate well and to provide stability and care for the two young people who currently live there. This is because they are looked after by staff who know them well and understand how to help them when they are upset or anxious.

Since the last inspection, a new manager has been appointed. They are continuing to be supported by the previous registered manager until the registration process is completed. There have been a few changes to the staffing structure, but this has not impacted on the young people.

The registered manager has been successful in making sure that the four requirements made at the last inspection have been met.

A new system to record and review medications has been introduced and all staff have

refreshed their knowledge in the safe administration of medication. As a result, there have been no further medication errors. A review of the induction process to include an improved level of self-harm and mental health training for new members of staff ensures that all the staff are suitably skilled and qualified to care for the young people.

Since the last inspection, one young person had a planned move to another home owned by the company. The registered manager reports that this young person has settled well and continues to have good relationships with the other young people and staff.

Young people continue to make progress. They regularly attend education whether it is college or specially designed learning opportunities. Records demonstrate that both young people are achieving in their chosen subjects.

The staff have a good understanding of the risks that the young people can place themselves in when they are not supervised. By following care and behaviour plans that are ratified by professionals, there has been a reduction in the incidents of self-harm and the need for physical intervention. When serious incidents have taken place, external agencies have been promptly and appropriately notified.

Young people are being helped to understand how to keep themselves safe by regularly accessing a team of qualified therapists provided by the company. Staff spoke positively about this resource. For example, staff are provided with opportunities to critically reflect following an incident and to develop improved strategies to support the young people.

## Information about this inspection

Inspectors have looked closely at the experiences and progress of children and young people. Inspectors considered the quality of work and the differences made to the lives of children and young people. They watched how professional staff work with children and young people and each other and discussed the effectiveness of help and care provided. Wherever possible, they talked to children and young people and their families. In addition, the inspectors have tried to understand what the children's home knows about how well it is performing, how well it is doing and what difference it is making for the children and young people whom it is trying to help, protect and look after.

This inspection focused on the effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection.

Using the 'Social care common inspection framework', this inspection was carried out under the Care Standards Act 2000 to assess the effectiveness of the service, how it meets the core functions of the service as set out in legislation, and to consider how well it complies with the Children's Homes (England) Regulations 2015 and the 'Guide to the children's homes regulations including the quality standards'.
