## **Summary of key findings for parents**

#### This provision meets requirements

- The childminder has a thorough understanding of how to help children make progress across all areas of their learning. She is aware of the requirements to complete the progress check for children aged between two and three years.
- The childminder values the importance of working in partnership with all those involved with children, including parents and other professionals and settings. She understands how to promote continuity and consistency for children.
- The childminder has procedures to follow to help her get to know children's specific needs and care routines. She is aware of how to promote children's well-being and inclusion.
- The childminder has a robust understanding of how to keep children safe from harm. She has clear procedures to follow if she has concerns about children's welfare and knows how to teach children about their own safety.
- The childminder is aware of the need to continually reflect on and enhance her skills and practice to work with children. She knows how to access further support from the local authority if this is needed.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

#### **Inspection activities**

- The inspector viewed the indoor and outdoor areas intended to be used by children.
- The inspector and childminder discussed the resources and equipment she intends to use with children.
- The inspector held discussions with the childminder about her knowledge and understanding of the safeguarding and welfare requirements.

The childminder registered in 2014 and lives in Bedale in North Yorkshire. She operates all year round, Monday to Friday from 7.30am until 6pm, with the exception of bank holidays and family holidays. The childminder provides early education places for two-, three-, and four-year-old children. She has a degree in early years. The childminder is registered to work with an assistant.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register.
