Summary of key findings for parents

This provision meets requirements

- The childminder has a secure understanding of how to report any safeguarding concerns she may have about children. She understands the importance of minimising risks to children, to help prevent accidents.
- The childminder has a valid qualification in paediatric first aid. She knows how to make an accurate daily record of children's hours of attendance.
- The childminder is aware of how to use effective care practices and provide for children's physical and emotional well-being. She understands the importance of promoting children's self-esteem and their motivation to learn.
- The childminder understands the importance of precise assessments of children's progress and how to use these, to help identify their next stage in learning. She recognises the need to provide activities that are matched to children's development and interests.
- The childminder understands the importance of working effectively with parents and other settings that children may attend to complement and extend their learning.
- The childminder is aware of the need to reflect on her practice and evaluate how she can bring about continuous improvement in the quality of provision. She understands how to seek the views of children and parents to support this.
- The childminder is able to explain how she would encourage children to develop independence through their play and daily routines. She knows how to help children manage their behaviour.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
