This provision meets requirements

- The manager describes how children are helped to settle into the club and develop relationships with her and the staff team. She talks about how she intends to gather information about children's interests and use this to plan activities that motivate them.
- Through discussion, the manager describes how she will plan activities that help children to complement the skills they learn in school. She describes how she will encourage children to take part in activities, such as cooking and baking, to enhance the mathematical skills involved in measuring and counting.
- The manager demonstrates how she intends to work with teachers in local schools to support children's learning. She talks about the information she intends to share with them and how she will work in partnership to support children's individual learning needs.
- The manager and her staff team have a good understanding of safeguarding procedures. They describe the signs that may indicate possible abuse to children and know how to report any concerns they may have about a child in their care.
- The manager describes how she reflects upon and evaluates the quality of the club. She seeks the views of children and parents and the support of her local authority to help her identify ways she can improve.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
