The children's home is owned and managed by a sole provider. It provides care for children and young people whose plan is for them to live in medium- to long-term residential care. The qualified and experienced manager has held registered manager status at this home since May 2016.

This inspection

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged good at the last full inspection. At the interim inspection, Ofsted judges that it has improved effectiveness.

The staff want the very best for the young people in their care. The care and support provided by the staff has made a sustained and meaningful difference. The young people have made continual progress. They have become more emotionally resilient, understand the advice given, and make changes to reduce risk-taking behaviour. The young people enjoy social activities, have learned age-appropriate independence skills, and have rebuilt positive family relationships.

Risk-taking behaviour continues to reduce, including missing-from-care incidents and child sexual exploitation risks. The staff are aware of the signs and take appropriate action to safeguard the young people. The young people respond well to the clear



boundaries and rules that keep them safe. This is a result of the strong and trusting relationships that they have built with the staff.

Most requirements from the last inspection have been met. Risk assessments have been reviewed regularly and include clear strategies to assist staff in reducing the identified risks. Safeguarding notifications to the regulator include the relevant information required to maintain oversight. The statement of purpose has been reviewed, and repeated information has been removed. The staff appropriately intervene when young people use offensive language, and they discuss positive social interactions with the young people. All staff have received training to develop their insight about responding to self-harming behaviours. The registered manager routinely receives formal supervision. Regulation 44 monitoring reports are sent to Ofsted in line with the regulations, and assist the manager on identifying any shortfalls.

One requirement is partially met. The regulation 44 independent visitor reports that the young people are safeguarded effectively. However, the visitor does not specifically give an opinion on whether the conduct of the home promotes children's well-being.

The manager has a positive involvement in the care practices and oversight of the home. Consistent care is provided by an experienced, well-trained and stable staff team. The young people benefit greatly from the improved and thorough auditing systems. These assist the manager considerably to monitor the quality of care that the young people receive, and this ensures their continual progress.
