# Information about this children's home

This home provides care and accommodation for up to three children and young people. The home accepts children and young people on a planned basis. The children and young people may have emotional and/or behavioural issues. The home aims to use a therapeutic approach. There is a new manager who has applied to become registered with Ofsted.

# This monitoring visit

This monitoring visit was carried out in order to address specific concerns. This was in response to a number of complaints being received by Ofsted.

At this visit, several shortfalls were identified. Many staff have left since the last inspection, particularly in January 2019. Not all young people feel safe. Young people have said that this is because staff who provided them with emotional support have left.

The staff team presents as chaotic. There have been disagreements between staff, and disagreements with managers. Young people have been aware of some of these disagreements, and this has had a negative impact on them.

In addition to this, some staff have left the home and then returned. Young people have found this confusing. Multiple staff changes have also impaired young people's progress. One new member of staff only worked at the home for three shifts, then left. They were influenced by negative comments from a colleague.

Leaders have been trying to resolve the staffing situation. They have remained committed to young people and have continued to both recruit staff and manage



personnel issues as they arise. Leaders feel let down by some staff, who have at times been unprofessional and difficult to manage.

The home is set up to provide care for three young people through a staff team comprising six and a half full-time equivalent members of staff. There are currently three permanent members of staff, and a bank worker. The bank worker has worked at the home for several months, after having previously left the home as a permanent employee. The most experienced permanent member of staff has only worked at the home for seven months. The other two staff members had only worked at the home for four weeks at the point of the inspection.

Young people have not been able to develop long-term, positive relationships with staff. Some young people, who have attachment difficulties, have found multiple staff changes particularly difficult.

There are examples of staff members' practice being poor. Two members of staff are reported to have used inappropriate language towards a young person. On another occasion, one young person overheard staff talking about complaints to Ofsted. Some staff have left suddenly, not saying goodbye to young people. Additionally, a young person reported that a member of staff said that they were leaving because of the manager. This particular situation had a significant impact on the young person.

Young people who have suffered previous trauma and require consistent, dependable care could be further traumatised from this very unsettled situation.

Management arrangements have not provided young people with stability. There have been three managers in the last 12 months. A new manager has applied to register with Ofsted. She is clear about the improvements needed but has been hampered by the difficulties within the staff team.

One requirement about staffing was made at the full inspection in April 2018 and was set again at the subsequent inspection in June 2018. This requirement has still not been met. This has now been escalated to a compliance notice.

Other requirements were not assessed at this monitoring visit and have therefore been carried over to the next inspection. Three recommendations were also not checked and have been carried over.

# What does the children's home need to do to improve?

### **Statutory requirements**

procedures that are designed to ensure children's safety. The registered person may only—	
employ an individual to work at the children's home; or if an individual is employed by a person other than the	



registered person to work at the home in a position in which the individual may have regular contact with children, allow that individual to work at the home, if the individual satisfies the requirements in paragraph (3).	
The requirements are that— the individual is of integrity and good character; the individual has the appropriate experience, qualification and skills for the work that the individual is to perform; full and satisfactory information is available in relation to the individual in respect of each of the matters in Schedule 2. (Regulation 32 (1)(2)(a)(b)(3)(a)(b)(d))	
This is with reference to agency staff, when the organisation or manager has not seen these checks for themselves. This requirement is repeated from the last inspection.	
The registered person must complete a review of the quality of care provided for children ('a quality of care review') at least once every 6 months.	15/04/2019
In order to complete a quality of care review the registered person must establish and maintain a system for monitoring, reviewing and evaluating— the quality of care provided for children; the feedback and opinions of children about the children's home, its facilities and the quality of care they receive in it; and any actions that the registered person considers necessary in order to improve or maintain the quality of care provided for children.	
After completing a quality of care review, the registered person must produce a written report about the quality of care review and the actions which the registered person intends to take as a result of the quality of care review ('the quality of care review report').	
The registered person must— supply to HMCI a copy of the quality of care review report within 28 days of the date on which the quality of care review is completed; and make a copy of the quality of care review report available on request to a placing authority, if the placing authority is not the parent of a child accommodated in the home.	
The system referred to in paragraph (2) must provide for ascertaining and considering the opinions of children, their	



parents, placing authorities and staff. (Regulation 45 (1)(2)(a)(b)(c)(3)(4)(a)(b)(5))	
This requirement is repeated from the last inspection. The protection of children standard is that children are protected from harm and enabled to keep themselves safe.	15/04/2019
In particular, the standard in paragraph (1) requires the registered person to ensure— that the premises used for the purposes of the home are designed, furnished and maintained so as to protect each child from avoidable hazards to the child's health. (Regulation 12 (1)(2)(d))	
This requirement is repeated from the last inspection.	
The registered person must ensure that— the privacy of children is appropriately protected; (Regulation 21(a))	15/04/2019
This requirement is repeated from the last inspection.	
The registered person must notify HMCI and each other relevant person without delay if— a child is involved in or subject to, or is suspected of being involved in or subject to, sexual exploitation; an incident requiring police involvement occurs in relation to a child which the registered person considers to be serious; there is an allegation of abuse against the home or a person working there; a child protection enquiry involving a child— is instigated; or concludes (in which case, the notification must include the outcome of the child protection enquiry); or there is any other incident relating to a child which the registered person considers to be serious. (Regulation 40 (4)(a)(b)(c)(d)(i)(ii)(e))	15/04/2019
This requirement is repeated from the last inspection.

#### Recommendations

Ensure that recruitment, supervision and performance management of staff safeguard children and minimise potential risks to them. ('Guide to the children's homes regulations including the quality standards', page 61,



paragraph 13.1)

- Staff need the knowledge and skills to recognise and be alert for any signs that might indicate a child is in any way at risk of harm. ('Guide to the children's homes regulations including the quality standards', page 43, paragraph 9.12)
- Ensure that care meets each child's needs and promotes their welfare, taking into account the child's gender, religion, ethnicity, cultural and linguistic background, sexual identity, mental health, any disability, their assessed needs, previous experiences and any relevant plans. This is with particular reference to one child's care plan, which did not incorporate all of this information. ('Guide to the children's homes regulations including the quality standards', page 14, paragraph 3.2)
