## Summary of key findings for parents

## This provision is good

- The managers and staff have successfully addressed the recommendations set at the last inspection. For example, they have increased the opportunities for children to understand how to consider risks to keep themselves safe.
- Effective partnerships with parents and other early years providers support staff well to meet children's individual needs. They work together consistently, sharing important information about children's development and care.
- Management uses self-evaluation systems well to help identify strengths and areas of improvement. They ensure that improvement plans focus sharply on areas to develop that benefit children's experiences.
- Outdoor play experiences are very good. Children benefit from long periods outside in all weathers and enjoy interesting activities that cover all areas of learning.
- Although staff closely monitor the progress of individual children, they do not check that different groups of children achieve as well as each other.
- On occasion, staff do not make the most of opportunities to extend children's good mathematical understanding.

## What the setting needs to do to improve further

## To further improve the quality of the early years provision the provider should:

- make better use of assessment information to check that all groups of children, such as boys and girls, are achieving as well as each other
- extend children's good mathematical skills, supporting staff to recognise and build on the opportunities that occur in children's everyday play and activities.

## **Inspection activities**

- The inspector spoke to parents and carers during the inspection and took account of their views.
- The inspector spoke to the trustees, manager, staff and children at appropriate times throughout the inspection.
- The inspector observed children and staff during activities and assessed the quality of teaching.
- The inspector completed a joint observation with the pre-school manager.
- The inspector held meetings with the trustees and manager. She looked at relevant documentation and evidence of the suitability of staff working in the pre-school.

## **Inspection findings**

## Effectiveness of leadership and management is good

Safeguarding is effective. The management team implement policies and procedures effectively, including safeguarding the use of mobile phones and cameras. All staff have a good understanding of how to keep children safe. They know the procedures to follow should they have a concern about a child's well-being. Recruitment and induction procedures are rigorous and help to ensure the ongoing suitability of staff. Managers observe staff regularly and give them feedback to help them improve their practice. They are committed to ongoing professional development. For example, staff are supported with completing further qualifications to improve their skills.

### Quality of teaching, learning and assessment is good

Staff plan for children's individual learning needs well and set appropriate next steps. Children confidently explore the environment, make choices about their own play and engage in activities. Staff encourage children to recognise and write familiar words, such as their name. This contributes to their good early literacy skills. Staff support children's growing communication and language effectively. They involve children in discussion and ask questions as they play alongside them. Opportunities for children to learn about the natural world are numerous. For example, they enjoy frequent trips to the nearby woodland where they can directly observe the changing seasons and identify trees and plants.

### Personal development, behaviour and welfare are good

Children develop a good understanding of healthy lifestyles. They are encouraged to manage their own self-help skills and care routines, such as toileting and handwashing. Children bring a healthy packed lunch and enjoy plenty of opportunities to be active outdoors. This provides them with good opportunities to run around, balance, climb and stretch. Children learn to manage their own safety, for example, when they take supervised risks while climbing on equipment outside. Staff encourage children to share and take turns and this helps them to develop good personal and social skills.

### Outcomes for children are good

Children make good progress and learn the skills needed to prepare them for their move on to nursery or school. Children are motivated to explore and investigate their environment. They listen attentively and respond well to instructions. Children are learning to be independent. For example, they collect their own packed lunches from the cloakroom and put their coats on before going outdoors. All children develop confidence in their own abilities and enjoy learning.

Chalfont St Giles Pre-School registered in 2004. The pre-school is in Chalfont St Giles and offers childcare during school term time only. The pre-school is open Monday to Wednesday from 9am to 3pm, and Thursday from 9am to 1pm. The pre-school is in receipt of funding for the provision of free early education for children aged two, three and four years. There are four members of staff, two of whom hold relevant childcare qualifications at level 2 or above.
