Summary of key findings for parents

This provision meets requirements

- The childminder knows how to assess children's individual starting points. She recognises how assessment information can be used, to plan and provide challenging activities that help children to make good progress.
- The childminder understands her role in keeping children safe. She is aware of the action to take should she ever have concerns about a child's well-being.
- The childminder is aware of the importance of keeping her knowledge and skills up to date. Since the last inspection, she has completed a relevant level 3 qualification.
- The childminder acknowledges the importance of working in partnership with parents and other settings that children attend, to help provide continuity of care and learning for children.
- The childminder understands the importance of setting clear boundaries to help guide children's behaviour and teach them to value and respect others.
- The childminder knows the importance of evaluating her provision. She acknowledges the advantage of involving others, including parents and children, to help identify areas for improvement.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector viewed the areas of the home used by children.
- The inspector viewed relevant documentation, including evidence of paediatric first-aid training and public liability insurance.
- The inspector asked the childminder questions throughout the inspection to establish her understanding of how to safeguard children, and how she would monitor their learning and development.
- The inspector and the childminder discussed how she would plan for children's play, activities and learning.
- The inspector discussed the self-evaluation process with the childminder.

The childminder registered in 2011 and lives in Staines-Upon-Thames, Surrey. She operates from 3pm to 6pm during term time only, Monday to Friday. The childminder holds a relevant level 3 qualification.
