Summary of key findings for parents

This provision meets requirements

- The childminder has a valid paediatric first-aid certificate and knows how to treat children in medical emergencies.
- The childminder has valid public liability insurance to meet regulatory requirements.
- The childminder knows how to identify and report any concerns she may have about a child's welfare.
- The childminder has good a understanding of effective behaviour management strategies, and would teach children to respect themselves and others.
- The childminder understands the value of working closely with parents and others to promote the best outcomes for children.
- The childminder understands how to provide appropriate activities for children. She understands how to keep a regular check on children's development to help to ensure they make good progress.
- The childminder knows how to evaluate her practice and set clear goals for improvement.
- The childminder understands the value of giving children healthy experiences, including daily physical challenges and well-balanced meals and snacks, which meet special dietary requirements.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The childminder registered in 2017 and lives in Feltham, in the London Borough of Hounslow. She operates all year round from 7.30am to 6pm, Monday to Thursday, except for bank holidays. The childminder holds a level 3 qualification in childcare.
