This monitoring visit

On 15 February 2019, Ofsted issued a notice restricting accommodation at the home. This was because during a monitoring visit in February the inspector found significant shortfalls. These included having an unqualified and inexperienced staff team, unsafe recruitment, inconsistent staffing arrangements and a failure to meet the home's statement of purpose. It was Ofsted's view that there was a risk to young people's safety and welfare, should any further young people be admitted to the home. In addition, two compliance notices were served in relation to staff recruitment and staff training.

This monitoring visit found that some progress had been achieved.

- There is now a full staff team.
- A new manager has been appointed and is due to start in May 2019.
- Staff have received training to enable them to meet the needs of one young person who has autism spectrum disorder.
- A new therapist has been recruited. This means that young people will be able to access therapeutic support as set out in the home's statement of purpose.

Despite this progress, fundamental shortfalls remain. For example, staff recruitment remains weak. Managers have not investigated why some staff members have gaps in their employment history. There is an absence of verification made by managers as to why a member of staff who has previously worked with children and/or

vulnerable adults might have left these positions. This leaves young people at continued risk of potential harm.

There are poor arrangements in place to manage risk and to ensure that young people are safe. For example, one young person has physically assaulted another young person through targeted behaviour that staff have been unable to manage safely. Following these incidents, staff have failed to put in place additional safeguarding measures that help to protect young people and/or ensure that risk assessments are brought up to date.

When young people display bullying behaviour towards others, staff are too slow in challenging this behaviour and do not provide a detailed record of the action taken.

The staff rotas do not detail members of staff's full names. It is also difficult to establish how many hours staff have worked. This shortfall means that managers do not have an accurate record of which staff are working with young people and the times they have been required to work.

As a result of this visit, the home was issued with a further compliance notice. The restriction of accommodation notice remains in place.

The requirements raised during the full inspection will be revisited during the next full inspection.

Recommendations

■ Ensure that just as in a family home, children are able to access all shared areas of their home unless there are specific reasons why this would not meet a child's needs. Limits on privacy and access may only be put in place to safeguard each child in the home (Regulation 21 (c)(i)). Any decisions to limit a child's access to any area of the home, and any modifications to the environment of the home, must only be made where this is intended to safeguard the child's welfare. All decisions should be informed by a rigorous assessment of that individual child's needs, be properly recorded and be kept under regular review ('Guide to the children's homes regulations including the quality standards', page 15, paragraph 3.10).

This is with reference to ensuring that bedroom door alarms are used only on the basis of individual safeguarding need.
