Summary of key findings for parents

This provision meets requirements

- The childminder holds a current paediatric first-aid certificate. This means that she has up-to-date knowledge of how to meet the needs of children in the event of an accident.
- The childminder completes risk assessments to help keep her premises safe. She recognises what may constitute a risk or hazard to children of all ages.
- The childminder is well qualified and experienced. She appreciates the significance of keeping up to date with professional development opportunities to refresh her knowledge.
- The childminder fully understands how to safeguard children and identifies the possible signs and symptoms of abuse and neglect. She talks about what she would do if she had any child protection concerns.
- The childminder discusses planning enjoyable activities based on children's individual interests and needs. She knows how to monitor children's progress and how to offer additional support to close any potential gaps.
- The childminder is knowledgeable about ways to support children with leading a healthy lifestyle. For instance, she intends to grow fruit in her garden with the children and attend sessions at the local children's centre about good hygiene procedures, such as the importance of brushing your teeth.
- The childminder is fully aware of the importance of working in partnership with parents. She has put in place effective strategies to ensure they are kept informed about their children's ongoing development.
- The childminder has considered ways to help her reflect on and improve her practice.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector viewed the resources and looked at the areas of the premises that are used for childminding.
- The inspector viewed relevant documentation, including evidence of paediatric first-aid training and public liability insurance.
- The inspector asked the childminder questions throughout the inspection to establish her understanding of how to safeguard children.
- The inspector and the childminder discussed the play activities and how she monitors their learning and development.

The childminder registered in 2013. She lives in North Kensington, in the London Borough of Kensington and Chelsea. The childminder holds a relevant childcare qualification at level 3. She works Monday to Thursday from 8.30am until 5.30pm, for most of the year, except for family and bank holidays.
